**II. OLD BUSINESS**

**A. I/M/O NICHOLAS ROSANIA, D.C.**

**C. GREGORY TRENTACOSTA, D.C.**

Dr. Trentacosta is seeking reinstatement to the active practice of Chiropractic following an Order that was entered on July 2, 2004. At the July 20, 2006 meeting, the Board reviewed the initial request and further sought a copy of the discharge report of Dr. Trentacosta's treating psychologists. That information was provided under a cover letter submitted by Joseph Portelli, Esq., on behalf of Dr. Trentacosta.
