A motion was made by Dr. Senatore, which was seconded by Dr. Allen, to approve the public session minutes of March 22, 2012 with one amendment- Dr. Berkowitz, who spoke during the public comment portion, first name is Robert not Richard. A vote was taken and the motion passed with all members present voting in favor.

A. CARLA J. MILLER, D.C. (INITIAL)

B. SCOTT E. YORKER, D.C. (REINSTATEMENT)

A motion was made by Dr. O'Connor, which was seconded by Dr. Senatore, to approve Dr. Yorker's reinstatement application for licensure. A vote was taken and the motion passed with all members present voting in favor.

A motion was made by Dr. O'Connor, which was seconded by Dr. Spadafino, to remove any remaining restrictions on Dr. Langeraap's license. A vote was taken and the motion passed with all members present voting in favor.

C. ERIC RODRIGUEZ, D.C.

The Board reviewed an assessment report/ request & evaluation filed by the CPEP on February 24, 2012.

This was accepted as informational.

D. ANTHONY LaRUSSO, D.C.

The Board reviewed a Consent Order filed on April 17, 2012.

This was accepted as informational.

VIII. INQUIRIES

A. FREDERICK PADAVANO, D.C.

Dr. Padavano inquired about whether he may enter a business relationship with a non-healthcare professional.

B. NICHOLAS MARINI, D.C.

Provide pro-bono work with the Catholic church.

A motion was made Dr. Senatore, which was seconded by Dr. Allen, to request additional information - what are the procedures you will use to perform an examination, document the patient treatment, maintain records, bill patients and/or insurance companies, etc.. A vote was taken and the motion passed with all members present voting in favor.

C. ELIZABETH NAPIER

Concerning needle EMGs

A motion was made by Dr. Calio, which was seconded by Dr. Senatore, that chiropractors are not permitted to perform needle EMGs in the State of New Jersey. Refer her to the electro-diagnostic regs.. The Board does not give legal advice to private individuals, and she should consult with a private attorney. A vote was taken and the motion passed with all members present voting in favor.

D. TIMOTHY SCHWEN

Use of ultrasound for weight loss

* This is outside of the scope of practice.

E. AL ORLANDI, DEPT. OF ENVIRONMENTAL PROTECTION

Several questions about the use of fluoroscopic x-ray equipment during a pain management procedure. Specifically, is a chiropractor permitted to perform fluoroscopy procedures under the direction of a medical doctor; is a chiropractor permitted to perform bone density procedures such as DEXA for osteoporosis;

* The Board will table this inquiry in order for the DAG to conduct further research on the laws and regulations.

F. ELYSE McNERGNEY

Can a D.C. direct an exercise physiologist in "spine stabilization" exercise.

A chiropractor may have an exercise physiologist assist them, but the chiropractor may not delegate this modality to an unlicensed individual. Refer to NJAC 13:44E-2.7.
