PUBLIC SESSION MINUTES
THURSDAY, NOVEMBER 19, 2015**

A meeting of the New Jersey Board of Chiropractic Examiners was held on October 22, 2015 at the State Office Building, 124 Halsey Street, 7th floor, Newark, New Jersey in the Somerset Conference Room on the 6th floor. The meeting was convened in accordance with the provisions of the Open Public Meetings Act with previous notification having been sent to the Secretary of State and the following publications: The Record, Newark Star Ledger, Camden Courier Post, Trenton Times and Asbury Park Press to advise of the scheduling of this meeting. The meeting was called to order by David Allen, D.C., President of the Board, at 9:45 A.M. A roll call was taken and the following attendance was recorded and a quorum was present:

I. APPROVAL OF THE PUBLIC SESSION MINUTES OF OCTOBER 22, 2015

A motion was made by Dr. Wartenberg, which was seconded by Dr. Stabile, to approve the public session minutes from the October 22, 2015 Board meeting as amended. A vote was taken and the motion passed with all members voting in favor.

II. CONTINUING EDUCATION COMMITTEE

The continuing education committee reviewed 89 courses submitted by continuing education sponsors. The committee recommended that 74 courses be approved based on the information submitted for these courses. The committee identified 14 courses where sponsor will be requested to provide additional information. The committee identified 1 course for the Board to review. A motion was made by Dr. Calio and seconded by Dr. Wartenberg, to approve the 74 courses as recommended by the committee. A vote was taken and motion passed with all members present voting in favor.

A. Sherman College of Chiropractic
Course - Chiropassion Transformative Weekend 2016

A motion was made by Dr. Calio, which was seconded by Dr. O'Connor to approve the course, "Chiropassion Transformative Weekend 2016" for 10 credits instead of the 12 credits as the content contains two hours of basic information on philosophy. A vote was taken and the motion passed with all members present voting in favor.

III. NEW BUSINESS

Upon a motion made by Dr. Lyons, which was seconded by Dr. Wartenberg, the Board voted to go into Executive Session to review and discuss applications for licensure and reinstatement. The motion carried by a unanimous vote. The Board returned to public session to continue the meeting and vote on the applications for licensure and reinstatement.

A. Application for Reinstatement

1. James Marsillo, D.C.

A motion was made by Dr. O'Connor, which was seconded by Dr. Wartenberg, to inform Dr. Marsillo that he must take and pass the Special Purposes Examination for Chiropractic (SPEC) as he has not practiced chiropractic in five years or more. A vote was taken and the motion passed with all members present voting in favor.

2. John Solan, D.C.

A motion was made by Dr. O'Connor, which was seconded by Dr. Wartenberg, to approve Dr. Solan provided he furnishes the Board with a statement as to whether he has practice during the time his license was expired. The Board will also request that Dr. Solan specify the nutrition and documentation courses that he has completed. A vote was taken and the motion passed with all members present voting in favor.

3. Hyunik Hwangbo, D.C.

A motion was made by Dr. O'Connor, which was seconded by Dr. Wartenberg, to approve Dr. Hwangbo's application for reinstatement provided he specifies the nutrition and documentation courses that he has completed and furnishes the Board with two additional credits. A vote was taken and the motion passed with all members present voting in favor.
