**COMMITTEE REPORTS:**

**Pending Dental Applications:**

1. Dr. Charito Murada - Application for a New Jersey dental license by N.E.R.B. past five years. The committee recommends approval.
2. Dr. Hector Mercedes - Application for a New Jersey dental license by N.E.R.B. past five years. The committee recommends that Dr. Mercedes be scheduled for an appearance before the Board to discuss the information provided on his application.
3. Dr. Gilda Barbour - Application for a New Jersey dental license by N.E.R.B. past five years. The committee recommends approval.
