## 898<sup>th</sup> BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JUNE 3, 2015

The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, unanimously passed, to approve (13) Initial Licenses effective June 3, 2015 to March 31, 2018.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve (14) Initial Business Permits effective June 3, 2015 to March 31, 2018.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (9) Initial Business Permits Previously Expired effective June 3, 2015 to March 31, 2018.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (1) Change in Business Permits effective June 3, 2015 to March 31, 2018.

Postal Money Order in the amount of \$100.00 received from Christian F. Rupp, IV, License #8149, #140, t/a CR Electrical Contracting, as the twenty-second installment of a civil penalty in the amount of \$2,700.00 for violation of #150. 45:5A-9 and #150. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$300.00.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Christine Higgins, NJ Electronic Security Association, requesting approval of a new course.

Motion made by Mr. Constantinos Papademas and seconded by Mr. James H. Flaherty, and unanimously passed, to approve four (4) new courses and instructors. Additionally, Ms. Higgins will be advised that the Board is only approving two (2) hours of the four (4) hour course. Licensed electrical contractors must attend all 4 hours in order to receive a certificate for the renewal of their license.

Mr. Constantinos Papademas recused himself from the following discussion and motion as he is the instructor seeking approval to teach courses for The Institute for Continuing Education.

The Board reviewed the application for Continuing Education Course/Seminar Approval received from Lois D'Apuzzo-Hammer, The Institute for Continuing Education, requesting approval of new courses.

Motion made by Mr. Gino Pasqualone and seconded by Mr. Joseph F. Cantalupo, and passed, to approve ten (10) new courses and an instructor.

The Board reviewed the application for reinstatement received from Luis M. Ferrao, License #8671 (Inactive).

Office files reflect Mr. Ferrao chose "Inactive" status on March 13, 2009. Business Permit #8671 expired on March 31, 1997.

Motion made by Mr. Gino Pasqualone and seconded by Mr. James H. Flaherty, and unanimously passed, that Mr. Ferrao's request to re-activate his license be held in abeyance pending receipt of copies of 34 hours of Continuing Education Certificates for the 2015 renewal cycle.

The Board reviewed an application for reinstatement received from Paul J. Mosticchio, License #10747 (Expired).

Office files reflect License and Business Permit #10747 expired on March 31, 2001.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Mosticchio's request be held in abeyance pending receipt of completed Work Experience Certification forms completed by his previous employers.

The Board reviewed an application for reinstatement received from James V. Colonno, License #6237 (Inactive).

Office files reflect Mr. Colonno chose "Inactive" status on March 13, 2006 for both License and Business Permit #6237.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Colonno's request be held in abeyance pending receipt of a detailed description of his hands-on experience during the time his license was inactive.

The Board reviewed Assembly Bill No. 4330 which permits the installation of automatic standby generators in certain residences without making application to the local planning or zoning board for a variance. This bill would streamline the process by which an owner or occupant of a single or two-family residential property may install an automatic standby generator. The installation of such generators is beneficial to both residents and communities.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board's position is neutral as it does not have jurisdiction over variances.

Rachel Glasgow, Regulatory Analyst, appeared before the Board to review the drafted rule proposal granting temporary licensure for nonresident military spouses.

Ms. Glasgow stated the temporary license/registration is valid for one year; howevr, at the end of the first year, the applicant may apply to the Board for an additional year.

Mr. Schooley asked that the language in  $\underline{N.J.A.C}$ . 13:31-2.7 (b) (2) be changed as follows:

Has been engaged in the active practice of working in the electrical field for at least two years of the five years immediately preceding the date of application for the temporary courtesy license, for which purpose relevant full-time experience in the discharge of official duties in the Armed Forces of the United States or an agency of the federal government shall be credited in the counting of years of service.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board approves the proposed language in <u>N.J.A.C.</u> 13:31-2.7 as amended.

Letter dated April 7, 2015, received from Karen E. Davis and Joseph T. Davis, IV, Davis Electric Electrical Contractor, requesting a six-month continuance of business under Permit #9595 according to N.J.S.A. 45:5A-14. The licensee, Joseph T. Davis, III, died on March 11, 2015.

Ms. Davis stated Joseph T. Davis, IV, has worked with his father for many years and will soon apply for his journeyman's registration card.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the firm of Davis Electric Electrical Contractor be granted a six-month continuance of business under permit #9595 according to N.J.S.A. 45:5A-14. The Board approves Joseph T. Davis, IV to qualify the business for the six-month period which will commence March 11, 2015.

Letter dated May 2, 2015, received from Paul Pairo, Pairo Electrical Contractors, requesting a third six-month continuance of business under Permit #785 according to  $\underline{\text{N.J.S.A}}$ . 45:5A-14. The licensee, Frank J. Pairo, Sr., III, died on May 7, 2014. The second extension expired on May 11, 2015.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Pairo's request is denied. Pairo Electrical Contractors must cease and desist from utilizing Business Permit #785 and return to the Board office the pressure seal issued to Pairo Electrical Contractors, Business Permit #785.

Letter dated March 20, 2015, received from James J. White, IV, President, J J White, Inc., requesting a six-month continuance of business. Mr. White stated Douglas Emenecker, License #17057, was the licensee for his company and has recently been terminated. Mr. White requests that James J. McGuckin be allowed to qualify the business for the six-month period.

Office files reflect James J. McGuckin submitted an application for examination which is pending.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. White advising him that the Board will allow J J White, Inc. to complete jobs already in progress, but will not be allowed to contract for new work until such time as the company acquires the services of a licensed electrical contractor to endorse the business permit to J J White, Inc. Mr. White will be directed to provide the Board with a listing of all New Jersey projects along with a copy of each permit.

Signed agreements received from Damien McDermott, Unlicensed, and Peter Kaiser, agreeing to include in advertisements which incidentally advertise electrical contracting services the truthful disclaimer, or a statement of similar effect, "all electrical work performed by licensed electrical contractors".

Signed cease and desist agreement received from Lee M. Humphries, Dunellen, New Jersey.

The Board accepted the signed cease and desist agreements.

Rafael Perez, Unlicensed, has failed to respond to a Uniform Penalty Letter offering him the opportunity to settle the matter by paying a civil penalty in the amount of \$1,500.00 for violation of N.J.S.A. 45:5A-9; restitution in the amount of \$182.50; and sign an agreement to cease and desist from engaging in the business of electrical contracting in the State of New Jersey until such time as he become licensed.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to finalize the Uniform Penalty Letter offering Mr. Perez the opportunity to settle the matter by paying a civil penalty in the amount of \$1,500.00 for violation of 81,500.00 for violation of 8

Mr. Pasqualone recused himself from the following discussion and motion as he knows Mr. Magee.

Frederick J. Magee, License #14622, has failed to respond to the Provisional Order of Discipline filed January 7, 2015, ordering he is provisionally reprimanded for his violation of N.J.S.A. 45:1-21(h) and N.J.S.A. 45:1-21(e); pay a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:1-21(e); pay restitution to the consumer in the amount of \$3,309.50; and License and Business Permit #14622 shall provisionally remain suspended until such time as Mr. Magee satisfies restitution and penalties assessed.

Motion made by Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that Mr. Magee is reprimanded for his violation of N.J.S.A. 45:1-21(h) and N.J.S.A. 45:1-21(e);

pay a civil penalty in the amount of \$1,000.00 for violation of  $\underline{\text{N.J.S.A}}$ . 45:1-21(h) and \$1,000.00 for violation of  $\underline{\text{N.J.S.A}}$ . 45:1-21(e); pay restitution to the consumer in the amount of \$3,309.50; and License and Business Permit #14622 shall remain suspended until such time as Mr. Magee satisfies the restitution and penalties assessed.

The Board discussed permitting staff to issue initial licenses and initial business permits on a daily basis and then presenting the list for final Board approval.

After a brief discussion, the following motion was made.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and passed, that initial licenses and initial business permits be issued on a daily basis with the proviso that there are no underlying complaints against the applicant applying for the license or business permit; applications are completed correctly; and include all pertinent documentation. The Board also requests that a certification be completed by the office staff person confirming same.

Mr. Papademas voted against the motion.

Ms. Widrich provided the Board with a sample of a Telecommunications Wiring Exemption certificate which shall be issued to the business.

Ms. Widrich stated when a telecommunications wiring exemption card is issued, a letter could be included which delineates the work the exempt applicant is allowed and not allowed to perform. The Board may require the applicant to sign the form and return same to the Board office.

This matter is being held in abeyance.

Board reviewed applications for the licensing examination to be administered by PSI Services, LLC. Nine (9) applications were approved.

The Board attended the Code of Ethics training course presented by Robert Campanelli, Ethics Officer, Division of Consumer Affairs.

Motion made by Mr. Constantinos Papademas and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
