

909th BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - JULY 6, 2016

The Board Minutes of July 6, 2016, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of September 7, 2016, or soon thereafter as it may be considered. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Board meeting of July 6, 2016, was called to order at 9:00 A.M.

Philameana L. Tucker, Executive Director, was present from 9:00 A.M. until the close of the meeting.

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Kerrie Shahan, Government Service Representative, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was Rich White and interns Josh, David and Christine, Division of Law.

The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (8) Initial Licenses which will expire on March 31, 2018. (Licenses were issued from May 20, 2016 through June 15, 2016).

July 6, 2016

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (12) Initial Business Permits which will expire on March 31, 2018. (Permits were issued from May 25, 2016 through June 10, 2016).

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (4) Initial Business Permits Previously Expired which will expire on March 31, 2018. (Permits were issued from May 26, 2016 through June 14, 2016).

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, to approve (7) Changes in Business Permits which will expire on March 31, 2018. (Permits were issued from May 24, 2016 through June 4, 2016).

Pursuant to N.J.S.A. 45:5A-5 the Board shall elect a chairman to preside over the meetings and an Executive Director to serve the Board during the period of July 6, 2016 to June 30, 2017.

Mr. James H. Flaherty nominated Mr. Joseph P. Schooley, and the nomination was seconded by Mr. Joseph F. Cantalupo.

Let the record reflect that Mr. Schooley has been elected Chairman for the Board from this date until the July 2017 meeting pursuant to N.J.S.A. 45:5A-5.

Mr. Joseph F. Cantalupo nominated Philameana L. Tucker, and the nomination was seconded by Mr. Gino Pasqualone.

Let the record reflect that Mrs. Tucker has been elected Executive Director for the Board from this date until the July 2017 meeting pursuant to N.J.S.A. 45:5A-5.

Check in the amount of \$1,000.00 received from Joseph M. Regan, License #9191, t/a Surfside Electric, as the eighth installment of a civil penalty, and costs, in the amount of \$31,110.78 for violation of N.J.S.A. 45:5A-9. Payments started November 11, 2004 and the balance due is \$6,713.78.

The Board accepted the payment.

July 6, 2016

Money Order in the amount of \$250.00 received from Marcin Rudnik, License #17784, t/a M & M Globe Electric, LLC, as the first and final installment of a civil penalty in the amount of \$250.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Check in the amount of \$500.00 received from Osvaldo J. Cruz, License #15652, t/a Antillas Electrical Contractor, as the first and final installment of a civil penalty in the amount of \$500.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

The Board reviewed an application for reinstatement of a license received from Harry K. Shute, License #16289 (Expired).

Office files reflect Mr. Shute's License #16289 expired on March 31, 2012.

Motion made by Mr. James H. Flaherty an seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that Mr. Shute's request be held in abeyance pending receipt of copies of W-2 income tax forms from 2012; a letter from his business manager if he is a union member; and a detailed explanation in regards to the affirmative answer identified in response to Question #8 of the application.

Mr. Schooley stated for the record that he spoke to an individual with Dirkes Electric, Inc., regarding their business permit paperwork.

Letter dated June 2, 2016, received from Gerald C. Dirkes, Sr., President, Dirkes Electric, Inc., requesting a continuance of business under Permit #1970 according to N.J.S.A. 45:5A-14. The licensee, Chester W. Dirkes, Jr., died on May 25, 2015.

Office files reflect Dirkes Electric, Inc. was granted a first and second extension on November 12, 2015 which expired on May 5, 2016.

Office files also reflect Dirkes Electric, Inc. was granted a final extension on May 10, 2016 which expired on June 30, 2016.

July 6, 2016

The Board was advised that a licensed electrical contractor will submit paperwork in order to endorse the business permit number to Dirkes Electric, Inc.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, that Mr. Dirkes be directed to immediately return the pressure seal issued to Dirkes Electric Inc. Mr. Dirkes will be advised that Dirkes Electric Inc. will be allowed to close out all open jobs, but cannot perform any new work.

The Board discussed documentation received from Bernard A. Purcell, III, who appeared before it on May 4, 2016, to describe in further detail the work his company performs.

Motion made by Mr. James H. Flaherty and seconded by Mr. Gino Pasqualone, and unanimously passed, that a letter be sent to Mr. Purcell advising him that he may perform testing of equipment as long as he does not remove equipment from the panel, including breakers, or take apart the panel. Mr. Purcell will be reminded to include a disclaimer in his New Jersey advertisements that he is not a licensed electrical contractor.

Mrs. Glasgow stated there were no comments regarding the proposal for the temporary license for nonresident military spouses.

Motion made by Mr. James H. Flaherty and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to adopt N.J.A.C. 13:31-2.7 and 5.7 Temporary Courtesy License and Registration for A Nonresident Military Spouse with no changes.

Ms. Tucker stated the Fire Alarm, Burglar Alarm, Locksmith Advisory Committee has discussed sending a memorandum to all Telecommunications Wiring Exemption holders reminding them they are not allowed to install control systems, CCTV Systems and Intercom Systems.

Mr. Schooley asked that a letter not be sent to exemption holders, but rather the Department of Community Affairs be asked to republish the memorandum dated May 13, 2016 from the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee to the Department of Community Affairs clarifying the business license categories that are required in order to install fire alarm and burglar alarm systems; perform locksmith work and install electronic access control, CCTV and intercom systems.

Additionally, Mr. Schooley asked Mr. Flaherty to chair a committee to draft language describing the work telecommunications wiring exemption holders cannot perform.

The Board reviewed applications for the licensing examination to be administered by PSI Services, LLC. Twenty-three (23) applications were approved.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Gino Pasqualone, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
