Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve six (6) new courses and instructors, and previously approved courses and instructors.

February 3, 2010

The sub-committee reviewed an application for Continuing Education Course/Seminar Approval received from Joseph J. Bevacqua.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve all new courses and instructors and previously approved courses and instructors. Additionally, Gregory Tomkins, Richard A. Hauser, and Joanne Z. Killmeyer are not approved to teach the course entitled "Permit and Inspection Requirements" as based on their resumes their expertise is not in the UCC.

Maryann Sheehan, Division of Consumer Affairs, appeared before the Board to discuss the decision by the Fire & Burglar Alarm Committee to delay the effective date of the amendments to the continuing education requirements in N.J.A.C. 13:31A-1.12(b)4.

Mrs. Sheehan stated that when the Committee's rules sun setted, the Committee made a change to their continuing education requirement. Because the rules become effective in the renewal period, the Committee wants to delay the effective date of the new changes until after the renewal cycle.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to ratify the Committee's recommendation in delaying the effective date of the amendments to the continuing education requirements in N.J.A.C. 13:31A-1.12(b)4.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fifty-seven (57) applications were approved.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
