

**770 BUSINESS MEETING
OF THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS
(PUBLIC SESSION) - - - FEBRUARY 4, 2004**

The Board Minutes of February 4, 2004, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of March 3, 2004. All requirements of the "Open Public Meeting Act" have been complied with according to N.J.S.A. 10:4-6.

The notice of the meeting has been mailed to the Newark Star Ledger, Camden Courier Post, and the Trenton Times, and also notice has been posted on the Bulletin Board at the office of the Secretary of State, Trenton, New Jersey.

Meeting of February 4, 2004, was called to order at 9:00 A.M.
The following members were present:

Mr. Joseph P. Schooley, Chairman; Mr. Joseph F. Cantalupo; Mrs. Gail Best; and Susan Carboni, Deputy Attorney General, Division of Law, were absent. Mrs. Connie F. Calisti left the meeting at 1:00 P.M.

Barbara A. Cook, Executive Director, was present from 9:00 A.M. until the close of the meeting.

Marian Fiore, Sr. Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Secretarial Assistant, III, was present from 9:00 until the close of the meeting.

Michelle Albertson, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance were Mr. James Bibbo, Central Jersey Electrical League and Mr. Scott Shauger, New Jersey Electrical Contractors Association.

The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mrs. Pushpavati Amin, and unanimously passed, to approve the Minutes of the 769 Meeting held January 7, 2004.

Motion made by Mrs. Pushpavati Amin and seconded by Mrs. Connie F. Calisti, and unanimously passed, to approve (16) Initial Licenses effective February 4, 2004 to March 31, 2006.

Motion made by Mrs. Pushpavati Amin and seconded by Mrs. Connie F. Calisti, and unanimously passed, to approve (18) Initial Business Permits effective February 4, 2004 to March 31, 2006.

Motion made by Mrs. Pushpatavi Amin and seconded by Mr. James H. Flaherty, and unanimously passed, to

approve (10) Initial Business Permits Previously Expired effective February 4, 2004 to March 31, 2006.

Motion made by Mrs. Pushpavati Amin and seconded by Mrs. Connie F. Calisti, and unanimously passed, to approve (10) of the (11) Changes in Business Permits effective February 4, 2004 to March 31, 2006. (#5 is being held in abeyance pending further review)

Checks in the amount of \$100.00 each received from Tom Iaione, License #9256, as the eleventh, twelfth and final installment of a civil penalty in the amount of \$1,200.00 for violation of N.J.A.C. 13:45C-1.2. Payments started August 11, 2003.

The Board accepted the payment.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the fourteenth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$2,150.00.

The Board accepted the payment.

Postal Money Order in the amount of \$250.00 received from Leo Anselmo, Unlicensed, as the sixth installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started July 25, 2003 and the balance due is \$1,000.00.

The Board accepted the payment.

Check in the amount of \$4,500.00 received from Max Brooks, Unlicensed, as the second and final installment of a civil penalty in the amount of \$5,000.00 for violation of N.J.S.A. 45:5A-9. Payments started December 3, 1998.

The Board accepted the payment.

Check in the amount of \$100.00 received from Juan Vela, License #9471, as the fourth installment of a civil penalty in the amount of \$1,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.A.C. 13:31-1.10 (recodified as 13:31-3.3(c)). Payments started September 3, 2002 and the balance due is \$900.00.

The Board accepted the payment.

Check in the amount of \$3,000.00 received from Kenneth Babineau, License #10816, t/a New Horizon's Technologies, Inc., as the first and final installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.S.A. 45:5A-15; N.J.S.A. 45:1-21(n); and N.J.A.C. 13:31-3.5.

The Board accepted the payment.

Check in the amount of \$2,500.00 received from Eric Beauvais, Unlicensed, t/a Live Wire Electric, LLC, as the

first and final installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq.

The Board accepted the payment.

Letter dated January 9, 2004, received from Dominic M. Yannetta, Sr. requesting a continuance of business under permit #1109. The licensee Angelo Yannetta, License #1109, died on August 7, 2003.

Mr. Yannetta stated that his son, Dominick, has applied to take the January 5, 2004, examination.

Motion made by Mr. Mitchell R. Malec and seconded by Mrs. Pushpavati Amin, and unanimously passed, that a letter be sent to Dominick Yannetta advising him that the Board has granted the firm of Yannetta Electric Co., Inc. a six-month continuance of Business Permit #1109 according to N.J.S.A. 45:5A-14.

Letter dated December 12, 2003, received from Jorge Acevedo requesting a second six-month continuance of business under permit #11447. The licensee, Mark A. Gandy, License #11447, died on August 10, 2003.

Mr. Acevedo's first extension will expire on March 5, 2004.

Mr. Acevedo is requesting this extension so that he can take the electrical contractor's examination.

Motion made by Mrs. Pushpavati Amin and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Jorge Acevedo advising him that the Board has granted the firm of Mark Gandy Electrical Contractor a second and final six-month continuance of Business Permit #11447 according to N.J.S.A. 45:5A-14.

The sub-committee reviewed the application for Continuing Education Course/Seminar Approval received from A. Alan Chech requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mrs. Pushpavati Amin, and unanimously passed, that a letter be sent to Mr. Chech advising him that the courses, and instructors, are approved as submitted. Mr. Chech will also be advised that he is approved to teach the Nine Hours of Code Changes and the One Hour of Laws, Rules, and Regulations.

The sub-committee reviewed the application for Continuing Education Course/Seminar Approval received from Alfred H. Schroth requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mrs. Connie F. Calisti, and unanimously passed, that a letter be sent to Mr. Schroth advising him that the courses, and instructors, are approved as submitted. Mr. Schroth will be also be advised to forward to the Board, under separate cover, his request to obtain continuing education credits as he teaches a preparatory course to applicants who will be taking the electrical contractor's examination.

The Board requested that Deputy Attorney General Susan Carboni research N.J.A.C. 13:31-1.7(d2) to ascertain what is meant by "new".

The sub-committee reviewed the application for Continuing Education Course/Seminar Approval received from

Valerie L. Francis, Rockhurst University, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mrs. Pushpavati Amin, and unanimously passed, that a letter be sent to Ms. Francis advising her that the courses entitled "How to Comply with OSHA Regulations on the Construction Site" and "The Essentials of Human Resources" are not approved. The Board requests that Ms. Francis provide clarification of the length of hours and a course outline for both the six hour course and the 12 hour course. The remainder of the courses, and the instructors, are approved as submitted.

The subcommittee reviewed a letter dated January 13, 2004, received from John A. Drebitko, South Jersey Electrical Contractors, Assoc., requesting that four instructors be added to previously approved courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mrs. Pushpavati Amin, and unanimously passed, that a letter be sent to Mr. Drebitko advising him that his request is being held in abeyance as he did not provide a breakdown of the courses that each instructor will be teaching.

Maryann Sheehan, Regulatory Analyst, Division of Consumer Affairs, discussed with the Board the comments received concerning the 24 hour Emergency Service Number which provides that a locksmith business license holder engaged in the provision of electronic security system services must maintain an emergency number that is attended to on a 24 hour basis.

Mrs. Sheehan stated that comments were received from Mr. Eugene R. George, Jr.; Mr. Richard Olive; Mr. Louis Gildenberg; Mr. Charles Hoffman; Mr. Jack Cool; Mr. William Rhoads; Mr. Daniel Snyder; Mr. Charles W. Gibson, Jr.; Mr. Edward Fitzgerald; Mr. Edward J. Fitzgerald; Mr. William R. Settles; Mr. Keith Moran; and Mr. William Timmann expressing opposition to this requirement. Mrs. Sheehan also stated that several commenters noted that the Act does not expressly require locksmiths to maintain such a number; rather they believe that the Act imposes the requirement upon alarm businesses only.

Mrs. Sheehan further stated that the Committee will respond stating that it sought to clarify the meaning of N.J.S.A. 45:5A-32(a)3 by expressly stating that the requirement in the Act concerning the maintenance of a 24 hour emergency service number is applicable to those locksmith business license holders who offer electronic security system services. The Committee believes that sound public policy dictates that locksmith business license holders, who choose to provide electronic security system services, should be required to provide consumers with an emergency service number. The Committee disagrees with the commenters' assertion that the requirement is not necessary for locksmith business license holders because of the type of services locksmiths offer. The Committee also believes that a consumer who chooses to obtain electronic security system services from a locksmith licensee is just as deserving of the protections afforded by a 24 hour emergency service number as is the consumer who chooses to obtain the same type of services from a burglar alarm or fire alarm installer.

Mr. Malec asked whether or not a company, that primarily installs locks, but has installed one electronic security system, would be required to offer a 24 hour emergency number.

Mrs. Sheehan stated that if a company installs electronic security systems, or advertises that they install electronic security systems, that company must provide a 24 hour emergency number. If the company is not installing, or advertising the installation of electronic security systems, that company would not be required to maintain a 24 hour emergency number.

Motion made by Mr. Mitchell R. Malec and seconded by Mrs. Pushpavati Amin, and unanimously passed, to approve the adoption of N.J.A.C. 13:31A-2.6(a)3 Locksmith Business License Holder Requirements, with the change as indicated.

A signed cease and desist agreement was received from Robert A. Bradley, Villas, New Jersey 08251

The Board accepted the signed cease and desist agreement.

The Board reviewed applications for the written examination to be administered by Experior Assessments, LLC. Nineteen (19) applications were approved.

Mr. Schauger stated that the association recently held a meeting and had scheduled ten one hour continuing education courses. A number of electrical contractors wanted to attend all ten courses in one day.

Mrs. Cook stated according to N.J.A.C. 13:31-1.7 (e1) credit shall not be granted for more than eight instructional hours obtained in one day.

Motion made by Mrs. Connie F. Calisti and seconded by Mrs. Pushpavati Amin, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
