

876th BUSINESS MEETING OF THE BOARD OF EXAMINERS
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - APRIL 3, 2013

Joseph Donofrio, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

The Committee saluted the Flag.

The Committee unanimously recommended to approve (12) Initial Licenses effective April 3, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (17) Initial Business Permits effective April 3, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (2) Initial Business Permits Previously Expired effective April 3, 2013 to March 31, 2015.

The Committee unanimously recommended to approve (13) Changes in Business Permits effective April 3, 2013 to March 31, 2015.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding Initial Licenses, Initial Business Permits, Initial Business Permits Previously Expired, and Changes in Business Permits.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to ratify the Committee's recommendations for the approval of Initial Licenses, Initial Business Permits, Initial Business Permits Previously Expired, and Changes in Business Permits.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding the approval of the 873rd, 874th and 875th Minutes as follows.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to ratify the Committee's recommendations, including any changes, for the Minutes of the 873rd Open Session Committee Meeting held January 9, 2013; the Minutes of the 874th Open Session Committee Meeting held February 6, 2013; and the Minutes of the 875th Open Session Committee Meeting held March 6, 2013.

April 3, 2013

Two checks in the amount of \$200.00 each received from Robert T. Brown, License #10584, t/a R T Brown Electrical Contracting, Inc., as the sixth and seventh installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-13.1 et seq.; N.J.S.A. 45:1-21(h); N.J.A.C. 13:31-1.7(b & c). Payments started November 14, 2012 and the balance due it \$1,100.00.

The Committee unanimously recommended to accept the payment.

Letter received March 25, 2013, from Douglas Caruso requesting a six-month continuance of business under Permit #1544 according to N.J.S.A. 45:5A-14. The licensee, Robert Caruso, died on March 14, 2013.

Douglas Caruso stated that he has been working full time for his father since 1978.

The Committee unanimously recommended that a letter be sent to Douglas Caruso advising him that the Committee grants the firm of Caruso Electrical Contractor a six-month continuance of Business Permit #1544 according to N.J.S.A. 45:5A-14.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding Mr. Caruso.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to ratify the Committee's recommendation that the firm of Caruso Electrical Contractor be granted a six-month continuance of Business Permit #1544 according to N.J.S.A. 45:5A-14.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from Phiphop Phillip Sengchanh, Silent Knight by Honeywell, requesting approval of new courses.

The Committee unanimously recommended to approve six (6) new courses and instructors.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding Silent Knight by Honeywell.

April 3, 2013

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed to ratify the Committee's recommendation to approve six (6) new courses and instructors.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from Thomas Valeo, requesting approval of new courses.

The Committee unanimously recommended to approve six (6) new courses and instructors.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding Thomas Valeo.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to ratify the Committee's recommendation to approve six (6) new courses and instructors.

The Committee reviewed an application for Continuing Education Course/Seminar Approval received from James Bailey, Philips, requesting approval of new courses.

The Committee unanimously recommended to approve three (3) new courses and instructors. The Committee is disapproving Mr. Philips' request that licensees be credited for attending courses not previously approved by the Board. Pursuant to N.J.A.C. 13:31-1.7 licensees shall be granted credit for having attended Board approved courses.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding James Bailey, Philips.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to ratify the Committee's recommendation to approve three (3) new courses and instructors. The Committee is disapproving Mr. Philips' request that licensees be credited for attending courses not previously approved by the Board. Pursuant to N.J.A.C. 13:31-1.7 licensees shall be granted credit for having attended Board approved courses.

Response received from Gary Nowicki, License #6808, to the Provisional Order of

Discipline ordering that Mr. Nowicki is provisionally reprimanded and assessed a civil penalty in the amount of \$537.50 for violation of N.J.A.C. 13:31-1.7(b) and N.J.S.A. 45:5A-9.

The Committee unanimously recommended that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that the civil penalty in the amount of \$537.50 for violation of N.J.A.C. 13:31-1.7(b) be waived as Mr. Nowicki provided proof of having completed 34 hours of continuing education courses. The reprimand is to be sustained as Mr. Nowicki used two business names in violation of N.J.S.A. 45:5A-9.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding Mr. Nowicki.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, to ratify the Committee's recommendation that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that the civil penalty in the amount of \$537.50 for violation of N.J.A.C. 13:31-1.7(b) be waived as Mr. Nowicki provided proof of having completed 34 hours of continuing education courses. The reprimand is to be sustained as Mr. Nowicki used two business names in violation of N.J.S.A. 45:5A-9.

Letter dated November 25, 2012, received from Robert Saganski, License #4254, in response to the Provisional Order of Discipline filed on November 7, 2012, ordering that Mr. Saganski pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2. Additionally, Mr. Saganski's License and Business Permit #4254 were to be provisionally suspended until such time as he responds to the Board.

The Committee unanimously recommended that this matter be discussed in Executive Closed Session to receive advice of counsel.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding Mr. Saganski.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to ratify the Committee's recommendation that this matter be

discussed in Executive Closed Session to receive advice of counsel.

After discussion in Closed Session, the Board returned to Public Session for a motion regarding this matter.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that DAG Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline ordering that the civil penalty assessed against Mr. Saganski be reduced to \$500.00 for violation of N.J.A.C. 13:45C-1.2 as Mr. Saganski did respond to the complaint received.

Letter dated June 14, 2012, received from Michael J. Revness, Esq., Kurtz & Revness, P.C., on behalf of John P. Cioffi who has applied to the Board to take the electrical contractor's examination. Mr. Cioffi was sent a letter disapproving his application as it did not appear that he has five years of experience in compliance with the National Electrical Code.

The Board directed that Deputy Attorney General Joseph Donofrio draft a letter to be sent to Mr. Revness advising him that based on the application for examination submitted by Mr. Cioffi it does not appear that he has five years of experience in compliance with the National Electrical Code. Mr. Cioffi's hands on experience appears to be low voltage wiring.

Letter dated November 27, 2012, sent to Mr. Revness advising him that Mr. Cioffi's application for examination is disapproved as he did not possess the requisite experience requirements pursuant to N.J.S.A. 45:5A-9(b) and N.J.A.C. 13:31-2.1(a) (3).

Letter dated January 10, 2013, was received from Michael J. Revness, Esq., Kurtz & Revness, P.C., requesting that the full Board review this matter.

The Committee unanimously recommended that a letter be sent to Mr. Revness advising him that the full Board denied Mr. Cioffi's application for examination as reflected in DAG Donofrio's letter dated November 27, 2012.

Mr. Flaherty participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding Mr. Cioffi.

April 3, 2013

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, that a letter be sent to Mr. Revness advising him that the full Board denied Mr. Cioffi's application for examination as reflected in DAG Donofrio's letter dated November 27, 2012.

Charles Manning, Regulatory Analyst, appeared before the Board to discuss his meeting with the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee concerning the adoption notice for Continuing Education Regulations.

Mr. Manning stated that he discussed with the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee the Board's concerns regarding the adoption notice for Continuing Education Regulations for the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee. Mr. Manning also stated that he advised the Committee that the Board felt that its' response that there is enough change to warrant two hours of continuing education in Barrier Free Subcode; New Jersey Uniform Construction Code; American with Disabilities Act Code; Industrial Safety; and Laws and Rules is inaccurate.

Mr. Manning stated that the Committee still believes that there were enough changes to warrant two hours and also felt that licensees should have sufficient knowledge in each topic.

Mr. Manning also stated that he did change the response to the comment concerning N.J.A.C. 13:31A-1.12(b) to say that the Committee disagrees with the commenter who indicated that the information contained in these five topics does not change very much. The Committee believes it is important for licensees to refresh their knowledge in these topics even if there have been no changes over the past triennial renewal period. The Committee will not amend N.J.A.C. 13:31A-1.12, 2.1, and 3.1 as the commenter recommended.

The Committee unanimously recommended to approve the adoption of N.J.A.C. 13:31A-1.12 Fire Alarm, Burglar Alarm and Locksmith Advisory Committee Continuing Education Requirements; N.J.A.C. 13:31A-1.16 Change in Business Qualifier; N.J.A.C. 13:31A-2.1 Requirements for Locksmith Licensure; N.J.A.C. 13:31A-3.1 Requirements for Burglar Alarm or Fire Alarm Licensure.

Mr. Papademas participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding the adoption.

April 3, 2013

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, to ratify the Committee's recommendation to approve the adoption of N.J.A.C. 13:31A-1.12 Fire Alarm, Burglar Alarm and Locksmith Advisory Committee Continuing Education Requirements; N.J.A.C. 13:31A-1.16 Change in Business Qualifier; N.J.A.C. 13:31A-2.1 Requirements for Locksmith Licensure; N.J.A.C. 13:31A-3.1 Requirements for Burglar Alarm or Fire Alarm Licensure.

Rachel Glasgow, Regulatory Analyst, appeared before the Board to discuss the Telecommunications Wiring Exemption; Continuing Education; and hands-on experience required for approval to take the electrical contractor's examination.

Ms. Glaskow stated that she drafted language for the Telecommunications Wiring Exemption which distinguishes the business entity and the individual applying for the exemption. Ms. Glaskow also stated that in order to apply for the exemption, the business entity must provide the full name of the qualifying employee for that business entity.

The Board requested that N.J.A.C. 13:31-4.1(3) be changed to read as follows:

A certification that the qualifying employee is familiar with and will comply with applicable National Electrical Code Requirements, including, but not limited to, Article 800 (communication circuits) and the State Uniform Construction Code Act, N.J.S.A. 52:27D-119 et seq., and its implementing rules set forth in the Uniform Construction Code, N.J.A.C. 5:23, and the qualifying employee will be responsible for obtaining **any required permits** and inspections for all work.

Ms. Glaskow stated that she has also included language to indicate if the employee who qualified the business entity ceases to be associated with the business entity, the exempt entity shall immediately notify the Board and provide it with the name of the individual who will assume the duties of the qualifying employee.

The Committee unanimously recommended to approve the drafted proposed language, as amended, for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption.

Mr. Papademas participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding the proposed language.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and

unanimously passed, to ratify the Committee's recommendation to approve the drafted proposed language, as amended, for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption.

Rachel Glaskow also discussed the drafted Pre-Proposal for N.J.A.C. 13:31-4.1 Telecommunications Wiring Exemption.

Ms. Glaskow stated that the Board is not obligated to go forward with the Pre-Proposal; however, if published, the Board may get a sense of what type of changes are needed.

The Board requested that Ms. Glaskow remove the word "local" from the drafted language inviting comments as to whether or not anyone other than the qualifying employee should be able to obtain (local) permits when required.

The Committee unanimously recommended to approve the drafted language in the Notice of Pre-Proposal, as amended, for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption.

Mr. Papademas participated in today's meeting by telephone which then enabled the Board to ratify the Committee's recommendations regarding the Pre-Proposal.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to ratify the Committee's recommendation to approve the drafted Notice of Pre-Proposal, as amended, for N.J.A.C. 13:31-4.1 Limited Telecommunications Wiring Exemption.

DAG Donofrio advised Ms. Glaskow that the Board has received applications from applicants that are seeking to qualify for the examination but their experience is mainly in fire and burglar alarm installation. DAG Donofrio also stated that it is the Board's position that the experience must be in all phases of electrical contracting.

The Board's regulations are ambiguous and it would be beneficial if we clarified that the experience must be in all phases of electrical contracting and not limited to only fire and burglar alarm experience.

DAG Donofrio also stated the Board would like the regulations to stipulate that full-time

experience is considered to be a minimum of 1800 hours in a calender.

DAG Donofrio further stated that the Board would further like the regulations to require that applicants who are licensed in another state submit W-2 income tax forms, or similar tax record, along with their application for examination as a type of verification of employment.

Ms. Glaskow stated that she will draft language for the Board's review.

Mr. Malec advised Ms. Glaskow that there are many organizations and associations that provide continuing education courses to its licensees for the renewal of their license. However, the sponsor must first receive Board approval before offering these courses to licensees.

Mr. Malec also stated that it seems illogical not to recognize those organizations/associations and give them blanket approval to teach continuing education to licensees as long as the organization/association meets the Board's general guidelines.

Ms. Glaskow stated that she will draft language for the Board's review.

Mr. Malec stated that the April 2013 examination was given the day after a holiday. Mr. Malec suggested that Patrick Hayes, Thomson Prometric, be invited to appear before the Board to discuss test site locations and test dates.

Mr. Schooley stated that Mr. Hayes never responded to the Board regarding the complaints received from applicants who sat for the April 4, 2011 examination. Mr. Schooley also stated that Mr. Hayes advised that he would meet with Prometric to address all of the Board's issues; however, the Board has not been informed of the outcome of that meeting.

Mr. Freed stated that he will inquire about test site locations and dates and invite Mr. Hayes to appear before the Board.

April 3, 2013

Mr. Schooley requested that the Board consider a policy stipulating that electrical contractors taking courses approved by the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee can be applied toward the 34 hours of continuing education required to renew their electrical contractor's license.

DAG Donofrio stated that he was advised by the regulatory analyst that this Board's approval of the sponsor/course is still needed.

This matter is being held in abeyance and will be discussed at a future meeting.

Mr. Schooley stated that he was asked whether or not landscape lighting needs to be performed by a licensed electrical contractor.

The Committee determined that if wiring for the landscape lighting is field installed and is ten or more volts, whether or not the system is pre-assembled or a plug-in system, such work must be performed by a licensed electrical contractor holding a business permit pursuant to N.J.A.C. 13:31-3.8(b) installing, maintaining or servicing wiring for the supplying of power from the service point on a customer's premises to an appliance or other equipment used by the customer for the purpose of light, heat or power, shall be performed only by a licensee holding a business permit, except as provided in N.J.S.A. 45:5A-18 and N.J.A.C. 13:31-3.8 (c).

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Fifteen (15) applications were approved.

The Committee unanimously recommended to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
