

**784 BUSINESS MEETING OF THE BOARD OF EXAMINERS  
OF ELECTRICAL CONTRACTORS (PUBLIC SESSION) - - - - APRIL 6, 2005**

The Board Minutes of April 6, 2005, have not been formally approved and are subject to change or modification by the Public Body at its next meeting of May 4, 2005. All requirements of the "Open Public Meetings Act" have been complied with according to N.J.S.A. 10:4-6.

Motion made by Mr. James H. Flaherty and seconded by Mrs. Pushpavati Amin, and unanimously passed, to approve the Minutes of the Special Meeting held February 16, 2005.

The Board accepted the payment.

Two Postal Money Orders in the amount of \$300.00 each received from John J. The Board accepted the payment.

Check in the amount of \$50.00 received from Walter Kohleim, License #9286, as the fourth installment of a civil penalty, and costs, in the amount of \$3,503.70 (penalty \$100.00 and costs \$3,403.70) for violation of N.J.S.A. 45:5A-17 and N.J.A.C. 13:31-1.8 (recodified as 13:31-3.2). Payments started November 13, 2002 and the balance due is \$2,300.00.

The Board accepted the payment.

Checks in the amount of \$1,000.00 each received from Joseph Regan, License #9191, as the third and fourth installment of a civil penalty, and costs, in the amount of \$31,110.78 (penalty \$30,000.00 and attorney's fees \$1,110.78) for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 17, 2004 and the balance due is \$23,100.78.

The Board accepted the payment.

Letter dated March 17, 2005, received from Thomas J. Demcsak, President, Scholes Electric & Communications, requesting a six-month continuance of business under permit #8772 according to N.J.S.A. 45:5A-14. The licensee, Richard Addeo, died on March 8, 2005.

Mr. Demcsak stated that he will apply for a business permit under his License #4319 shortly.

Motion made by Mr. James H. Flaherty and seconded by Mrs. Gail Best, and unanimously passed, that a letter be sent to Mr. Demcsak advising him that the Board has granted the firm of Adco Electrical Corp., t/a Scholes Electric & Communications a six-month continuance of Business Permit #8772 according to N.J.S.A. 45:5A-14.

Letter dated March 25, 2005, received from Charles P. Bonicker, Jr., CPB Electric, requesting a fourth six-month continuance of business under Permit #3984 according to N.J.S.A. 45:5A-14. The licensee, Earl J. Currey, on April 18, 2003.

Motion made by Mr. Robert A. McCullough and seconded by Mr. James H. Flaherty, and unanimously passed, that a letter be sent to Mr. Bonicker advising him that the Board has granted the firm of CPB Electric a final continuance of Business Permit #3984 according to N.J.S.A. 45:5A-14. The extension will expire on May 31,

2005. Mr. Bonicker will be advised that this is the final extension being granted to CPB Electric. Therefore, if necessary, he should make arrangements with a licensed electrical contractor with a business permit to complete any unfinished jobs after the extension has expired.

Additionally, licensees who have attended courses that were previously taught by the National Electrical Contractors Association will receive credit as long as sign in and sign out sheets are provided by the sponsor. These courses are nationally developed and approved by NICET and the Board does not feel that licensees should be penalized for having attended courses that were not previously approved by the Board.

The sub-committee reviewed the application for Continuing Education Course/Seminar approval received from Kenneth Krug requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mrs. Gail Best, and unanimously passed, that a letter be sent to Mr. Krug advising him that his request is being held in abeyance pending an explanation as to the type of audio visual aides he intends to use.

Motion made by Mr. Robert A. McCullough and seconded by Mrs. Gail Best, and unanimously passed, that the following course is denied as Mr. Biondi has not provided a detailed breakdown and course description.

The sub-committee reviewed a letter dated March 24, 2005, received from Michael Landolfi requesting approval to teach the One Hour of Laws, Rules and Regulations. Mr. Landolfi has been approved to teach the nine hours of continuing education and was issued Instructor No. 84. Mr. Landolfi was issued License #7562 on September 1, 1984.

Motion made by Mr. Robert A. McCullough and seconded by Mrs. Gail Best, and unanimously passed, that Mr. Landolfi is approved to teach the One Hour of Laws, Rules, and Regulations. Mr. Landolfi will be requested to forward to an updated resume.

Letter dated March 23, 2005, received from Mrs. Murch on behalf of her husband, Dennis Murch, License #7439, t/a Murch Electric, Inc., stating that her husband was scheduled to attend a continuing education class in September 2004 which was canceled. Mr. Murch was then scheduled to attend a class on March 25, 2005; however, he will not be able to attend this class due to health reasons.

Motion made by Mr. Robert A. McCullough and seconded by Mrs. Gail Best, and unanimously passed, that a letter be sent to Mr. Murch advising him that his request for a waiver of the Continuing Education Course is denied at this time as there are still eleven months left in the renewal cycle. Mr. Murch will also be advised that should he still not be able to attend continuing education courses by September or October 2005, he is to request an extension at that time and provide the Board with medical documentation.

Letter dated March 1, 2005, received from Jeff M. Hager, License #12375, requesting a waiver of the 34 hours of Continuing Education Courses. Mr. Hager stated that during the past triennial renewal period he has earned two masters' degrees, Master of Systems Engineering and Master of Business Administration.

Mr. Hager also stated that based on the completion of the two masters' programs, he has completed the required course of study pursuant to N.J.S.A. 45:5A-13.3.

Motion made by Mr. Robert A. McCullough and seconded by Mrs. Pushpavati Amin, and unanimously passed, that a letter be sent to Mr. Hager advising him that his request for a waiver is denied as the courses he attended do not meet the criteria of continuing education. Mr. Hager will also be advised that he may choose to place his license in "inactive" status.

The Board reviewed a memorandum dated March 21, 2005 received from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the second quarter of Fiscal Year 2005, the Electrical Board was directly billed for 121.1 hours of Deputy Attorney General/Paralegal services totaling \$14,486.04.

Chuck Manning, Regulatory Analyst, Division of Consumer Affairs, appeared before the Board at 9:15 A.M. to review and discuss Assembly Bill A-3897 which establishes licensing requirements for those persons engaged in the business of heating, ventilating and air conditioning contracting and the responsible collection and disbursement of chlorofluorocarbons and other refrigerants to protect the environment. The bill establishes the

State Board of Examiners of Heating, Ventilation and Air Conditioning Contractors which shall consist of nine members. The bill enumerates specific practices in which a licensed master plumber may be engaged, provided that he does not hold himself out to the public as a licensed HVAC contractor. In addition, the bill denotes specific work that is permissible for licensed electricians to perform.

Mr. Manning stated that he appreciates the fact that the Board has taken the time to review the bill and provide their comments. Mr. Manning also stated that he was not clear of the position of the Board; there were many comments and questions about the bill, but no one indicated whether they supported or opposed the bill.

Mr. Manning also stated that the Attorney General asks the Board to provide their input because of their expertise. However, the bill comment period is not an opportunity for the Board to ask questions. Instead, the Board should comment that a particular statement in the bill needs to be corrected and why. Mr. Manning stated that the Board can provide information even after the time for comments has passed.

Mrs. Amin stated that a professional engineer should also be a member of the HVAC Board.

Mr. Manning stated that he will include the comment that the Electrical Board suggests that a professional engineer serve as a member of the HVAC Board.

Mr. McCullough stated that the bill indicates that nothing in this act shall be construed to prevent licensed master plumbers from performing electrical work; however, this tells us that the HVAC contractor will be allowed to install the wiring. Mr. McCullough also stated that HVAC contractors should not be allowed to install the wiring from a dedicated electrical service disconnect box.

Mr. Manning stated that the comment will be that such work can only be performed by a licensed electrical contractor.

Mr. McCullough stated that in section 22, the language which references section 2 and 21 of this act, should be deleted. This will allow the language to specifically state that licensed master plumbers and HVAC contractors are not allowed to perform work with a potential of more than thirty volts.

Mr. McCullough also stated that the words "gasoline or diesel oil dispensing equipment" should be deleted from the definition of HVAC.

Mr. McCullough further stated that Section 10 should be clarified to say that the utility is exempt when performing emergency repair services.

Mr. Flaherty stated that the words "solar energy" found in Section 10 should be deleted as such work should only be performed by a licensed electrical contractor.

Motion made by Mr. Robert A. McCullough and seconded by Mr. James H. Flaherty, and unanimously, that the Board supports Senate Bill A-3897 with their comments as stated above.

Mrs. Cook advised the Board that there are approximately 500 instructors, more than 87 sponsors, and over 3,000 courses.

Mrs. Cook also stated that there is a larger number of applicants taking the electrical contractors examination. Therefore, individuals who were scheduled to take the April 2005 examination, were rescheduled for the next examination.

Mrs. Cook further stated that licensees will be offered the opportunity to renew their license and business permit on line and pay via a credit card. The records entered by the licensee on line will automatically update the information in the Board's data base. Additionally, renewals will be mail forwarded to licensees who may have moved but did not inform the Board of their new address.

Mr. Schauger stated that the Board should not allow licensees to receive credit for having attended courses that were not previously approved.

Mr. McCullough stated that pursuant to N.J.A.C. 13:31-1.7(h) sponsors of continuing education courses shall obtain Board approval in each triennial period prior to representing that any course, seminar, or program fulfills the requirements of this section. Mr. McCullough also stated that in his opinion this section of the law stipulates that sponsors are not allowed to advertise that a course has been approved by Board until it receives such approval.

DAG Carboni stated for the record, that during the break she spoke to the attorney for Comcast, Mr. De Angelis, who requested a copy of the letter that the Board received regarding work being performed by Comcast, which is to be discussed in Closed Session, so that he may respond on their behalf.

The Board reviewed applications for the written examination to be administered by Experior Assessments, LLC. Six (6) applications were approved.

Meeting adjourned at 2:30 P.M.
