The Board reviewed an application for Continuing Education Course/Seminar Approval received from Dennis Campbell, Comprehensive Education Solutions, LLC.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve all previously approved courses and instructors including Mr. Campbell's request to increase the hours of the course entitled "Solar Photovoltaic Systems".

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Leah Alexio, National Fire Protection Association.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve six (6) new courses and instructors.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Alice Haines, IEC Chesapeake.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve seventeen (17) new courses and instructors. The course entitled "Solar Hot Water Systems" is not approved as the course does not appear to be specific to electrical contractors. The courses entitled "NABCEP Entry Level Preparation", "Advanced PV Systems Design & Install", and "NABCEP Installer Certification Test Preparation" are being held in abeyance as it does not appear that the total course hours are electrical in nature; therefore, the Board requests that Ms. Haines provide it with a more detailed description of the courses to be taught and a breakdown of the electrical aspects that are being covered.

Letter received March 29, 2012, from George P. Brown, License #13925, t/a George Brown Electric, requesting a waiver of the Continuing Education Courses for the 2012 triennial renewal period pursuant to N.J.A.C. 13:31-1.7.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Brown advising him that the Board has denied his request for a waiver; however, the Board grants him an additional six months in which to take his courses. Upon completion of the courses, Mr. Brown will be requested to forward to the Board copies of his certificates totaling 34 hours. Additionally, the Board requested that he provide it with a brief explanation as to how he is supervising his employees.

Letter dated March 11, 2012, received James J. Mullin, License #11480, requesting a waiver of the Continuing Education Courses for the 2012 triennial renewal period pursuant to N.J.A.C. 13:31-1.7.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, that a letter be sent to Mr. Mullin advising him that his request for a waiver is being held in abeyance pending receipt of medical documentation giving the date he first became ill and how long he will be under a doctor's care.

Chuck Manning, Regulatory Analyst, appeared before the Board to discuss with it N.J.A.C. 13:31A-1.14, Standards of Practice, a regulation change for the Fire Alarm, Burglar Alarm, and Locksmith Advisory Committee.

Mr. Manning stated that this language would require licensees, who have subcontracted to perform burglar alarm, fire alarm, or locksmithing services, to inform the client receiving those services that he or she has subcontracted to perform the services and to provide the client receiving those services with his or her name and license number.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Burglar Alarm, Fire Alarm, Locksmith Advisory Committee be requested to clarify the language and define "client".

Provisional Order of Discipline filed on March 7, 2012, ordered Jorge Hernandez, License #12278, to pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:31-3.5. Mr. Hernandez paid the civil penalty assessed against him.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Arthur W. Jacobs, Sr., and unanimously passed, that Deputy Attorney General Joseph Donofrio finalize the Provisional Order of Discipline and issue a Final Order of Discipline reflecting that Mr. Hernandez has paid his penalty in full.

Diggs, Jr., License #1226, to pay a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:45C-1.2 and that Mr. Digg's License and Business Permit #12266 are suspended until such time as he appears before the Board.
