

**797 BUSINESS MEETING OF THE BOARD OF EXAMINERS OF ELECTRICAL
CONTRACTORS (PUBLIC SESSION) - - - MAY 3, 2006**

Barbara A. Cook, Executive Director, was present from 9:00 A.M. until the close of the meeting.

Marian Fiore, Sr. Management Assistant, was present from 9:00 A.M. until the close of the meeting.

Kathleen Moran, Administrative Assistant, III, was present from 9:00 A.M. until the close of the meeting.

Susan Carboni, Deputy Attorney General, Division of Law, was present from 9:00 A.M. until the close of the meeting.

Also in attendance was James Bibbo, Central Jersey Electrical League.

The Board saluted the Flag.

Motion made by Mr. James H. Flaherty and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve the Minutes of the 796 Meeting held April 5, 2006.

Mr. Cantalupo noted for the record that there is a correction in the 795 Minutes held March 1, 2006, on page 10 and 11 of Closed Session.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve (8) Initial Licenses effective May 3, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (12) Initial Business Permits effective May 3, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs. Connie F. Calisti, and unanimously passed, to approve (7) Initial Business Permits Previously Expired effective May 3, 2006 to March 31, 2009.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (25) Changes in Business Permits effective May 3, 2006 to March 31, 2009.

Check in the amount of \$1,000.00 received from Michael Cohen, Unlicensed, as the first installment of a civil penalty in the amount of \$5,000.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Postal Money Order in the amount of \$300.00 received from John J. Helmstetter, License #7192, t/a John Helmstetter Electrical Contractor, as the twentieth installment of a civil penalty in the amount of \$7,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started June 7, 2004 and the balance due is \$1,500.00.

The Board accepted the payment.

Check in the amount of \$500.00 received from Casey Morton, Unlicensed, as the third installment of a civil penalty in the amount of \$6,000.00 for violation of N.J.S.A. 45:5A-9. Payments started January 26, 2006 and the balance due is \$4,000.00.

The Board accepted the payment.

Check in the amount of \$100.00 received from Michael Delli Santi, Unlicensed, as the fifth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 29, 2005 and the balance due is \$1,900.00.

The Board accepted the payment.

The Board reviewed an application for reinstatement received from William F. McHugh as he failed to renew his License #12304 for the 1997 to 2000; 2000 to 2003; and 2003 to 2006 triennial renewal periods.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs. Connie F. Calisti, and unanimously passed, that a letter be sent to Mr. McHugh advising him that he must take and pass the written examination in order to regain his license.

Letter dated March 30, 2006, received from Jorge Acevedo requesting a third six-month continuance of business under permit #11447 according to N.J.S.A. 45:5A-14. The licensee, Mark A. Gandy, died August 10, 2003. The second extension expired on September 6, 2004.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, that a letter be sent to Mr. Acevedo advising him that his request is denied. It appears that he has been engaging in the unlicensed practice of electrical contracting as his second extension expired on September 6, 2004. Mr. Acevedo will be directed to return to the Board office the pressure seal issued to Mark Gandy Electrical Contractor within ten business days. Additionally, Mr. Acevedo is to provide the Board with a list of unfinished jobs along with the copies of permits.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Stephen Bialkowski.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that 4 new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Gregory Bierals.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that 1 new course, and instructors, are approved as submitted. The previously approved courses are also approved. Mr. Bierals will be advised that this approved course will be viewed as an 11 hour course, and not a 12 hour course, as the Board does not allow a quiz or exam to be part of the instructional hours.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Paul Brinkmann.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that 8 new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

Mr. Brinkmann will be advised that the courses entitled "Digital Camera Fundamentals for the Contractor"; "Introduction to Computers - Part I"; "Introduction to Computers - Part II"; "Using a Computer in an Electrical Contracting Business"; "E-Mail Fundamentals"; and "How to Buy and Sell Electrical Supplies, Tools, and Vehicles on Ebay" are not approved as they do not meet the criteria of Continuing Education pursuant to N.J.A.C. 13:31-1.7.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Steven M. Ripley.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that Mr. Ripley's request to teach 13 computer courses is denied as they do not appear to be related to the electrical industry.

Approval of the two courses entitled "ABC's of Marketing for the Electrical Contractor" (1 hour and 2 hours) is denied as the outline provided for both courses is identical.

Approval of the three courses entitled "Small Business & Self Employed Taxpayer Education & Communications" (1 hour, 2 hours and 4 hours) is denied as the outline provided for these courses is identical.

Approval of the three courses entitled "Construction Industry - Federal Taxation Curriculum" (1 hour, 2 hours and 4 hours) is denied as the power point presentation does not break down these courses. Additionally, the Board does not feel that the issuance of a certificate is a sufficient qualification for an instructor to teach these courses.

Further, Mr. Ripley will be requested to clarify his request to become the sponsor of previously approved courses for other sponsors. The Board would like to know from Mr. Ripley whether or not he has received approval from the other sponsors/instructors to teach these courses.

Three new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Kennie Fried.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that 2 new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from John Biondi.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Biondi advising him that the course entitled "Significant Changes to the Code" is being held in abeyance pending submission of a more detailed breakdown and description of the course content. The previously approved courses are approved.

The sub-committee to review an application for Continuing Education Course/Seminar approval received from Tom Pernal.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that 3 new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Joseph Knecht, Sr.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that 17 new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Eric J. Sivertsen.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that 3 new courses, and instructors, are approved as submitted. The previously approved courses are also approved.

The Board discussed appointing a committee to review its rules which will sunset on May 2, 2007.

The Board appointed Mr. Schooley, Mr. McCullough, Mr. Cantalupo and Mr. Flaherty to the sub-committee. A meeting will be scheduled to discuss this matter.

Signed cease and desist agreement received from Michael Cohen, Sussex, New Jersey 07461.

The Board accepted the signed cease and desist agreement.

Mr. Malec advised the Board that the adoption of the 2005 National Electrical Code was published in the May 1, 2006 New Jersey Register.

The Board reviewed applications for the written examination to be administered by Thompson Prometric. Twenty-one (21) applications were approved.

Motion made by Mrs. Connie F. Calisti and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
