The Board saluted the Flag.

June 6, 2012

Mr. Schooley requested a moment of silence for the Invasion of Normandy.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (21) Initial Licenses effective June 6, 2012 to March 31, 2015.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (24) Initial Business Permits effective June 6, 2012 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. James H. Flaherty, and unanimously passed, to approve (18) Initial Business Permits Previously Expired effective June 6, 2012 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Richard T. Aicher, Jr., and unanimously passed, to approve (6) Changes in Business Permits effective June 6, 2012 to March 31, 2015.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778 (Inactive), as the fifty-ninth installment of a civil penalty in the amount of \$2,500 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$1,025.00.

The Board accepted the payment.

Two Money Orders in the amount of \$1,000.00 each received from Jorge Hernandez, License #12278, t/a Geo Peak Electric, LLC, as the first and final payment of a civil penalty in the amount of \$2,000.00 for violation of N.J.A.C. 13:31-3.5.

The Board accepted the payment.

Check in the amount of \$250.00 received from Christopher Ledford, License #15515, t/a Ledford Electric, as the first and final payment of a civil penalty in the amount of \$250.00 for violation of N.J.A.C. 13:45A-16.2(a).

The Board accepted the payment.

June 6, 2012

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Meghan Roy Holt, Mike Holt Enterprises, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Ms. Holt advising her that the Board has not yet approved on-line courses. Ms. Holt will also be advised that she may reapply to the Board once a regulation has been adopted to allow licensees to earn credit for attending interactive, computer-based courses.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Marcus Denke, Infinite Solar, Inc.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructors. Mr. Denke will be advised that the Board is only approving twenty (20) hours of the forty (40) hour course. Licensed electrical contractors must attend all 40 hours in order to receive a certificate for the renewal of their license.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Terri Wettle, E-Hazard.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, to approve one (1) new course and instructors and previously approved courses and instructors including Ms. Wettle's request to add instructors to teach previously approved courses.

Letter dated May 5, 2012, received from George Cassidy, Jr., License #15107 (Expired), requesting an extension to attend Continuing Education Courses for the 2012 triennial renewal period. Mr. Cassidy stated that he was unable to take his continuing education courses as he was caring for a family member.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Cassidy advising him that the Board has granted his request for an extension to take the required 34 hours of Continuing Education. This extension will expire on October 1, 2012. Mr. Cassidy will be requested to forward to the Board copies of his Continuing Education Course certificates for the 2009 renewal period.

June 6, 2012

Letter dated May 4, 2012, received from William G. Leach, License #4581, t/a William G. Leach, Jr., requesting an extension to attend Continuing Education Courses for the 2012 triennial renewal period. Mr. Leach stated that he was unable to complete his courses due to illness.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Leach advising him that the Board has granted his request for an extension to take the required 34 hours of Continuing Education. This extension will expire on October 1, 2012. Mr. Cassidy will be requested to forward to the Board copies of his Continuing Education Course certificates for the 2009 renewal period. Mr. Leach will also be advised that he may not engage in the business electrical contracting in the State of New Jersey until he has submitted his Continuing Education Course certificates totaling 34 hours for the 2012 renewal period.

At its March 7, 2012 meeting, the Board reviewed a letter from Lawrence M. Hurwitz, License #12202, t/a Broadway Electrical Company, Inc., stating that his assistant renewed his license; however, Mr. Hurwitz has not taken the required continuing education courses. Mr. Hurwitz has provided medical documentation regarding his medical condition.

As per the Board's request, a letter dated April 18, 2012, was sent to Mr. Hurwitz asking him if his medical condition precludes him from carrying out the functions of his electrical contracting company; when he started treatment for his medical condition; did he complete any continuing education courses; and whether or not there are any jobs pending in the State of New Jersey and if so, is he supervising same.

Letter dated April 23, 2012, received from Mr. Hurwitz stating that his medical issues began on January 29, 2011 and since that time he has been unable to drive alone and traveling out state has been difficult. Mr. Hurwitz also stated that his company does not have any open jobs in New Jersey. Mr. Hurwitz further stated that he is still able to perform supervisory duties in Boston and should the opportunity arise to perform work in New Jersey, he would make other arrangements.

Motion made by Mr. James H. Flaherty and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Hurwitz advising him that his request is denied. Mr. Hurwitz will also be advised that he may not engage in the business electrical contracting in the State of New Jersey until he has submitted his Continuing Education Course certificates totaling 34 hours for the 2012 renewal period.

June 6, 2012

Cease and desist agreement received from Jim Antone, Marlton, New Jersey.

The Board accepted the signed cease and desist agreement.

The Board review applications for the written examination to be administered by Thomson Prometric. Fourteen (14) applications were reviewed.

Motion made by Mr. Richard T. Aicher, Jr. and seconded by Mr. Mitchell R. Malec, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
