The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the 799 Meeting held July 12, 2006.

Check in the amount of \$3,000.00 received from Howard Monahan, License #15209, as the first and final

The Board accepted the payment.

Check in the amount of \$50.00 received from Nick Ortense, Unlicensed, as the ninth and tenth installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started October 18, 2005 and the balance due is \$725.00.

The Board accepted the payment.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from John A. Drebitko.

The sub-committee reviewed an application for Continuing Education Course/Seminar approval received from Suzanne Borek.

The Board reviewed a memorandum dated July 17, 2006, received from Darlene Kane, Budget Officer, Division of Consumer Affairs, stating that for the fourth quarter of Fiscal Year 2006, the Board/Committee was directly billed for 187.3 hours of Deputy Attorney General/Paralegal services totaling \$22,265.33.

Signed cease and desist agreement was received from Vernon Walderon, Levittown, PA.

The Board accepted the signed cease and desist agreement.

After briefly discussing the complaint against Nortel Communications concerning the installation of telecommunications wiring, the following motion was made.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Seventeen (17) applications were approved.
