The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs. Pushpavati Amin, and unanimously passed, to approve the Minutes of the Special Meeting held October 22, 2003.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs. Pushpavati Amin, and unanimously passed, to approve the Minutes of the 767 Meeting held November 5, 2003.

Motion made by Mrs. Gail Best and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs Gail Best, and unanimously passed, to approve (13) Initial Business Permits effective December 3, 2003 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mrs. Gail Best, and unanimously passed, to approve (3) Changes in Business Permits effective December 3, 2003 to March 31, 2006.

Check in the amount of \$1,000.00 received from Edmund Peterwas, License #8037, as the first and final installment of a civil penalty in the amount of \$1,000.00 for violation of N.J.A.C. 13:31-3.4.

The Board accepted the payment.

Money Orders totaling \$3,500.00 received from Nicholas J. Tanasy, Unlicensed, as the first and final installment of a civil penalty in the amount of \$3,500.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Postal Money Order in the amount of \$250.00 received from Leo Anselmo, Unlicensed, as the fourth installment of a civil penalty in the amount of \$3,000.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started July 25, 2003 and the balance due is \$1,500.00.

The Board accepted the payment.

Checks in the amount of \$100.00 each received from Tom Iaione, License #9256, as the third, fourth, fifth, and sixth installment of a civil penalty in the amount of \$1,200.00 for violation of N.J.A.C. 13:45C-1.2. Payments started August 22, 2003 and the balance due is \$700.00.

The Board accepted the payment.

Checks in the amount \$1,000.00 and \$500.00 were received from Willie Welcome, Unlicensed, as the first and final installment of a civil penalty in the amount of \$1,500.00 for violation of N.J.S.A. 45:5A-9.

The Board accepted the payment.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the twelfth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1. Payments started September 25, 2002 and the balance due is \$2,200.00.

The Board accepted the payment.

Letter dated October 31, 2003, received from Neil J. Marascio, License #11719 (Expired) requesting that the Board reconsider its decision that he must take and pass the written examination in order to regain his license.

Mr. Marascio failed to renew his license for the 1997 to 2000; 2000 to 2003; and 2003 to 2006 triennial renewal period.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and passed, that the Board reaffirms its decision that Mr. Marascio must take and pass the written examination in order to regain his license.

Mrs. Pushpavati Amin and Mr. Joseph P. Schooley opposed the motion.

The sub-committee reviewed the application for Continuing Education Course/Seminar Approval received from Joseph J. Bello, Technical Educational Services, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Bello advising him that the courses, and instructors, are approved as submitted.

The sub-committee reviewed the application for Continuing Education Course/Seminar Approval received from Thomas Valeo, Instructor #179, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Valeo advising him that the courses, and instructors, are approved as submitted.

The sub-committee reviewed the application for Continuing Education Course/Seminar Approval received from James J. McGlynn, Municipal Electrical Inspector's Association.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. McGlynn advising him that the courses, and instructors (Mr. McGlynn and Mr. Drebitko) are approved as submitted. Before approving Mr. Santangelo as an instructor, the Board requests that he substantiate his teaching experience.

Let the record reflect that upon researching office files, it was found that Mr. Santangelo had previously submitted documents demonstrating he has the required teaching experience. Therefore, Mr. Santangelo is approved to teach the courses submitted by Mr. McGlynn.

Letter dated October 9, 2003, received from Richard Van Wert requesting approval to teach the ten hour Continuing Education Code Course.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve Mr. Van Wert to teach the Nine Hours of Code Changes and the One Hour of Laws, Rules, and Regulations.

The Board reviewed the proposed new rule, N.J.A.C. 13:31-4.3 Testing, Servicing or Repairing of Electrical Equipment or Apparatus, which was published in the New Jersey Register on October 20, 2003.

The Board reviewed applications for the written examination to be administered by Experior Assessments, LLC. Three (3) applications were approved.

Motion made by Mrs. Gail Best and seconded by Mrs. Pushpavati Amin, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
