The elements of these continuing education programs would appear to be outside the scope of activities regulated by the Fire Alarm, Burglar Alarm and Locksmith Advisory Committee and may be wholly or partially within the scope of activities of electrical contracting to the extent the systems are permanently installed and operate in excess of 10 Volts;

It has been previously determined that PERS systems are outside the scope of activities regulated by the Advisory Committee, nothwithstanding, should a contractor add a smoke detector, carbon

monoxide detector or burglar alarm device to the system, those activities without question are within the scope of the Advisory Committee's regulations;

The Advisory Committee also notes that its basic knowledge of these systems confirms that they do operate in excess of 10 Volts and that wiring for these systems may or may not be permanently installed in a residence or other structure.

The Advisory Committee defers review of the continuing education programs to the Board of Examiners of Electrical Contractors.

Discussion Of Adopted Rule Amendment, Effective October 5, 2009, Continuing Education Requirements, NJAC 13:31A-1.2C Sunsetting of The Advisory Committee Rules

NJAC 13:31A-1.12(c)

A licensee shall complete a minimum of two (2) continuing education credits in the Barrier Free Subcode, N.J.A.C. 5:23-7, two (2) continuing education credits in the New Jersey Uniform Construction Code, N.J.A.C. 5:23, exclusive of the Barrier Free Subcode, two (2) continuing education credits in the Americans with Disabilities Act Code, 36 CFR 1191 and two (2) continuing education credits in industrial safety per triennial registration period.

A licensee seeking renewal of a burglar alarm license shall complete a minimum of three credits of continuing education per triennial registration period in smoke detection systems. A licensee may take a maximum of 12 credits per triennial registration period in continuing education courses related to business and/or law. A licensee shall obtain the balance of continuing education credits in trade-related subjects.

The rule, previous to the amendment, required that licensees complete a minimum of one (1) continuing education credit in the Barrier Free Subcode, N.J.A.C. 5:23-7, one (1) continuing education credit in the New Jersey Uniform Construction Code, N.J.A.C. 5:23, exclusive of the Barrier Free Subcode, and one (1) continuing education credit in the Americans with Disabilities Act Code, 36 CFR 1191.

Since the rule was amended during the the current triennial licensing period, the Advisory Committee discussed whether to impose the new rule immediately, waive the rule until the next triennial licensing period, to provide an alternative for licensees who may have already completed the code seminars in compliance with the previous rule, or to allow licensees the alternative to complete the seminar in compliance with the previous rule, or, in compliance with the amended rule.

Subsequent to discussion, the Advisory Committee determined, due to the date of the adopted

rule and it's potential impact on the completion of required continuing education for the renewal of licenses on August 31, 2010, that the completion of one (1) continuing education credit in the Barrier Free Subcode, N.J.A.C. 5:23-7, one (1) continuing education credit in the New Jersey Uniform Construction Code, N.J.A.C. 5:23, exclusive of the Barrier Free Subcode, and one (1) continuing education credit in the Americans with Disabilities Act Code, is acceptable for renewal of a license;

The Committee asked that correspondence be sent to continuing education sponsors regarding the determination;

Information with regard to the determination will be posted on the Advisory Committee web site as an "Alert".

Motion was made by Keith Eaves, seconded by Charles Okun and unanimously passed to accept the recommendations made by the Continuing Education subcommittee.

CHAIRMAN'S REPORT

A Chairman's report was not given at this meeting.

FOR ADVISORY COMMITTEE REVIEW

- IMO Professional House Doctor, Unlicensed, Response To A Cease And Desist Order

At the December 15, 2009 meeting, the Advisory Committee reviewed the response received from Reuel Topas, Esq., attorney for Professional House Doctor, with regard to a Cease and Desist Agreement sent to Sender Baumrind, owner, for alleged unlicensed practice of providing locksmith services.

In his response, Mr. Topas contended that Professional House Doctor provides services which are not defined within the regulatory definition of "Locksmithing services" (N.J.A.C. 13:31A-1.3). Mr. Topas also contended that Mr. Baumrind is essentially a handyman who installs prefabricated locksets and doorknobs for residential clients.

After review and discussion, motion was made by Jon Sprague, seconded by Arthur Fucetola, and passed unanimously that Deputy Attorney General Donofrio contact Mr. Topas and inform him that the Advisory Committee has determined once again that Mr. Baumrind, on behalf of Professional House Doctor, is engaged in the unlicensed practice of providing locksmith services.

The matter was revisited at this meeting. After further review of Mr. Topas' correspondence, motion was made by Charles Okun, seconded by Robert Boyer, and passed unanimously to send correspondence to Mr. Topas, accepting accept the explanation with regard to the scope of services provided by Mr. Baumrind, on behalf of Professional House Doctor and withdraw the previously issued Cease and Desist Agreement if Mr. Baumrind removes any references to locksmithing in his advertising. Also the Advisory Committee suggested that Mr. Baumrind, on behalf of Professional House Doctor, apply for a Home Improvement Contractor certification.

- IMO USA Locksmith (Prestige Business Solutions), Response To A Provisional Order Of **Denial (Aaron J. Solomon, Esq.)** (Tabled From The December 15, 2009 Meeting)

The Advisory Committee reviewed the response received from Aaron J. Solomon, Esq., attorney for USA Locksmith. Since Deputy Attorney General Donofrio prepared the Provisional Order, the Advisory Committee tabled the matter until the February 16, 2010 meeting, since Mr. Donofrio is expected to be present.
