## **APPEARANCES**

Michael Conte, Application #1025073

CM Michael Fitzpatrick recused himself from the review of this application.

Michael Conte appeared before the Committee to explain why he could not provide proof that he had performed paid inspections. He explained his inability to obtain tax and wage statements substantiating his previous work experience as a home inspector due to his former employer's failure to forward his payroll withholding taxes to the IRS and Social Security offices. A recommendation will be made at the November meeting.

Ray Farruggia, Associate Home Inspector, #214GX00011000

Mr. Farruggia, an associate home inspector, appeared before the Committee with his attorney, Leah Bourne, to discuss his desire to surrender his associate home inspector license so that he may work without supervision, and perhaps reapply under the grandfather provision. The Committee requested a DAG opinion on whether a licensee can surrender their license. The Committee advised Mr. Farruggia that if he surrendered his associate home inspector license he would not be able to reinstate it.

Edward Zinck (UL)

Previously, the Committee invited Mr. Zinck to appear before the Committee to discuss his team approach of using multiple inspectors to perform a home inspection. At the present time Mr. Zinck works independently and performs home inspections by himself. The Committee advised him to perform his home inspections in accordance with its standards of practice.

#### **DISCUSSION ITEM**

The Committee scheduled the issue of obtaining continuing education credit for conducting training inspections to the November 2004 meeting.
