5. REGULATORY MATTERS

Charles Manning, Regulatory Analyst – Continuing Education Topics N.J.A.C.13:32A-4.3

On March 1, 2016, Chuck Manning discussed the publishing of the CE topics as a "Notice" in the New Jersey Register.

N.J.A.C. 13:32A-4.1 requires licensed master HVACR contractors to complete five credits of continuing education every biennial renewal period. N.J.A.C. 13:32A-4.3 requires that one (1) hour of continuing education be in Statutes and Rules governing the practice of heating, ventilating, air conditioning, and refrigeration and that one (1) hour be in propane services. N.J.A.C. 13:32A-4.3 requires the Board to determine the topics required for the remaining three (3) hours. The Board has determined that these three (3) hours shall be devoted to any topic relevant to the practice of heating, ventilating, air conditioning, and refrigeration as defined by N.J.A.C. 13:32A-1.2.

Plumbing Inspectors and Mechanical Inspectors:

A motion was made by Daniel G. Danko, Jr. and seconded by Dominic D. Demico, Jr. to request amendments to N.J.A.C. 13:32A-4.4 so that inspectors licensed by the Department of Community Affairs would be required to complete only the hour of continuing education in Statutes and Rules. A vote was taken and the motion unanimously passed.

6. CONTINUING EDUCATION WELCOMING CONTINUING EDUCATION SPONSORS

All Licensed Master HVACR Contractors are exempt from the Continuing Education (5) five hour requirement for this first biennial renewal of July 1, 2016 to June 30, 2018, according to N.J.A.C 13:32A-4.1 License Renewal; Continuing Education Requirement.

All Licensed Master HVACR Contractors must complete the (5) five hour requirement CE requirement for the <u>following</u> biennial renewal:

July 1, 2018 to June 30, 2020

This requirement must be met before the next renewal date of July 1, 2018.

Continued ...

N.J.A.C. 13:32A-1.2 DEFINITIONS

"Bona fide representative" means a licensed master HVACR contractor who:

- 1. In the case of a sole proprietorship, is the owner of the business;
- 2. In the case of a partnership, is a partner in the business;
- 3. In the case of a limited liability company, is a manager; or
- 4. In the case of a corporation, is an executive officer.

Such a designation, and notifying the Board of that designation, will permit Sears to perform HVACR services for consumers in the State of New Jersey. Secondly, Sears must also comply with:

N.J.A.C. 13:32A-5.3 BONA FIDE REPRESENTATIVE RESPONSIBILITIES (6) Maintain a place of business in the State of New Jersey or designate, and notify the Board of the identity of, an agent or entity in New Jersey for service of process. The Board does not have the authority to waive statutory requirements. A motion was made by Paul J. Mitchell and seconded by Daniel G. Danko, Jr. A vote was taken and the motion passed unanimously.

Are Master HVACR Contractors allowed to reconnect power wiring on replacement HVACR package units without an electrician after disconnect?

On March 1, 2016, Board Members discussed this matter and concluded in a motion made by Dominic D. Demico, Jr. and seconded by Daniel G. Danko, Jr., that "Yes" Master HVACR Contractors are allowed to reconnect power wiring on replacement HVACR package units without an electrician after disconnect.

Members clarified that this task is permitted from the disconnect to the unit, and referred the inquirer to N.J.S.A. 45:16A-2. "Definitions relative to licensing of HVACR contractors," "HVACR" means.... in replacement cases only, the connection thereof of the wiring from an electrical service disconnect box of adequate size to accommodate the equipment and controls and previously dedicated to that equipment..."

A vote was taken and the motion unanimously passed.

9. Joseph Battaglia, EMAIL January 29, 2016, - owner of small appliance repair company

Do we need an HVACR license to repair small household refrigerators seeing that we do not do any electrical, plumbing or heating and cooling work?

On March 1, 2016, Board Members discussed this matter and concluded in a motion made by Dominic D. Demico, Jr. and seconded by Daniel G. Danko, Jr., that "Yes" a Master HVACR Contractor's license is required for the repair of small household refrigerators.

A vote was taken and the motion unanimously passed.

On March 1, 2016, Board Members discussed this matter and concluded in a motion made by Daniel G. Danko, Jr. and seconded by Dominic D. Demico, Jr., that, "No" A Master HVACR Contractor cannot perform the electrical work on walk-in coolers that he installs. The Board referred to N.J.A.C. 13:32A-1.3 ELECTRICAL WORK.

Members agreed that while the circumstances are unfortunate with regard to Mr. Pace's situation, the existing New Jersey HVACR Statutes and Regulations do not permit a waiver allowing him to grandfather for his license.

Mr. Pace, however, may consider the option to apply for his license by examination. That application and the qualifications are available at the Board's website. A motion was made by Dominic D. Demico Jr. and seconded by Daniel G. Danko, Jr.

A vote was taken and the motion unanimously passed.
