• Propane

A discussion was held as to the procedure the HVACR Board will follow with respect to educating licensees on propane. The HVACR will proceed as the State Board of Examiners of Master Plumbers in educating all licensees through Continuing Education with a competency exam to follow; secondly, educating applicants through apprenticeship training. Chuck Manning agreed to return with a draft rule.

• Veteran education

Subsequent to a discussion on this matter, a vote was made by Daniel G. Danko, Jr. and seconded by Dominic D. Demico, Jr., to approve the regulation N.J.A.C. 13:32a-2.7. A vote was taken and the motion unanimously passed.

On April 15, 2014, the Board discussed this correspondence and noted that certifications for propane are issued by the Department of Community Affairs in Trenton, NJ. Natural gas piping does require a Master HVACR license.

Inquiry concerning an above ground heating oil storage tank (AST):

On April 15, 2014, Board Members discussed this matter and agreed that the installation and/or removal of an AST is within the HVACR scope of practice.

Inquiry: "Is PSEG exempt from the license requirements? We do residential HVACR work under our Worry Free contracts."

On April 15, 2014, Board Members discussed this matter and advised that any public utility is exempt under the HVACR Statutes and Regulations, and to the extent that PSEG is performing worry free contracts, they are exempt based on <u>N.J.A.C.</u> 13:32a1.1c and <u>N.J.S.A.</u> 45:16a-10.

"Do self contained household refrigerator repairs fall under HVACR New Jersey law 13:32A?"

On April 15, 2014, the Board discussed this inquiry responding that this type work is deemed HVACR work and referred the consumer to the Definition of HVACR as contained in the Statutes and Regulations.

Aerodyne-Redmond Environmental, Inc., Clifton, NJ
 Correspondence of March 19, 2014 - Public works projects

On April 15, 2014, Board Members discussed this correspondence and concluded that there is no distinction between public or private work. With respect to a corporation mentioned with two (2) owners who are mechanical engineers doing HVACR work, the Board responded by stating that at least one (1) of those contractors must be licensed as a Master HVACR contractor.

 Requiring liability insurance - April 10, 2014 email

On April 15, 2014, the Board discussed the correspondence dated April 10, 2014, from Mr. McAllister questioning if every licensee must obtain insurance, and responded as follows: No, not every licensee is required to obtain liability insurance. Licensed Master HVACR Contractors offering services to the public will be required to obtain general liability insurance. Members referred Mr. McAllister to the below regulation:

Pursuant to <u>N.J.A.C.</u> 13:32A-2.4 Licensure and pressure seal:

• A certificate of general liability insurance from an insurance company authorized and licensed to do business in New Jersey in the amount of \$ 500,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence or proof of self-insurance approved by the Department of Banking and Insurance, obtained by the applicant or the HVACR company or corporation, if the applicant will offer HVACR contracting services to the public, which includes instances when the applicant will act as a bona fide representative for a company or corporation.

 Larry Storr of Springfield, NJ - May 11, 2014 email "Is HVACR licensing required for a technician who works on appliances such as refrigerators and freezers? Mr. Storr advises that he works for a company that services small appliance-like freezer units."

On April 15, 2014, the Board responded by stating that the Master HVACR license is required for this type work.

"Does a commercial boiler repair business holding a NJR stamp for more than 20 years and a burner service on oil and gas for over 35 years, need to apply for the HVACR Contractors license?"

On April 15, 2014 the Board responded to this inquiry by stating the Master HVACR Contractor's license is required for this type work.
