Animal Land is a six button hand striker game. The game is played by choosing what type of animal the player wants to strike and then must attempt to hit the button that corresponds to the animal that appears on the video display. When a button is hit a hammer appears on the screen to hit the appropriate hole where the animal appears. Tickets are awarded based upon the number of hits made.

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately in the form of tokens or tickets.
- 3.) Game shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications.

This certification is not a license to operate the captioned gambling device. The device may only be operated in a location specifically approved for the operation of amusement games pursuant to the Law and Regulations.

The Commission reserves the right to suspend, revoke or modify this certification upon notice to the manufacturer and/or applicant.
