The above-mentioned game is approved for use in New Jersey as an amusement game, as defined in the Amusement Game Licensing Law, N.J.S.A. 5:8-100 et seq. ("Law"), and the regulations promulgated thereunder, N.J.A.C. 13:3-1.1 et seq. ("Regulations"). This approval is based upon information supplied by the applicant at the time of application for certification. The game must be operated in accordance with the specifications submitted and the terms of this certification. Any modification of the manufacturer's specifications or the specified method of play immediately voids this certification.

It is unlawful to license or operate any amusement game in the State of New Jersey without a valid Certification of Permissibility or in a manner not in accordance with Certification of Permissibility issued for the game. This Certification of Permissibility contains two pages. This is page 1 of 2.

GAME DESCRIPTION

Gold Zone is up to a six player position rotary coin game. The game is played by inserting a coin or token into a coin acceptor. The coin travels down a track to a rotating play field. The coin then travels along a stationary arm as the play field spins. Coins or tokens accumulate at the end of the stationary arm, and may be pushed off the play field. Each coin or token pushed off the play field awards a fixed value of tickets (default = seven tickets per fallen coin /token). Bonus holes are drilled through the play field. When a coin or token passes through a bonus hole, a progressive jackpot is awarded in tickets. All awards are dispensed as tickets to the player for price redemption.

CONDITIONS

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately upon a win.
- 3.) Game shall be clean and free of debris.
- 4.) The play field surface shall be free from any holes, burrs, blemishes or imperfections that would impede game play.
- 5.) Game shall be installed and maintained according to manufacturer specifications.

This certification is not a license to operate the captioned gambling device. The device may only be operated in a location specifically approved for the operation of amusement games pursuant to the Law and Regulations.

The Commission reserves the right to suspend, revoke or modify this certification upon notice to the manufacturer and/or applicant.
