The game must be operated in accordance with the specifications submitted and the terms of this certification. It is unlawful to license or operate any amusement game in the State of New Jersey without a valid Certification of Permissibility or in a manner not in accordance with Certification of Permissibility issued for the game. ## GAME DESCRIPTION

Jungle Jungle is a single player pinball-type redemption game. The game is designed with five rows of pegs and sixteen slots at the bottom of the playfield. The object of the game is for the player to shoot a ball into an illuminated slot. By depositing the ball into the illuminated slot, the player advances to the next round. If the player does not get the ball into an illuminated slot, the game is over and the accumulated points are awarded.

## CONDITIONS

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately in the form of tokens or tickets.
- 3.) Game shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications.

This certification is not a license to operate the captioned gambling device. The device may only be operated in a location specifically approved for the operation of amusement games pursuant to the Law and Regulations.

The Commission reserves the right to suspend, revoke or modify this certification upon notice to the manufacturer and/or applicant.
