The game must be operated in accordance with the specifications submitted and the terms of this certification. This certification is conditioned upon the following:

GAME DESCRIPTION

Sky Masters is a two player position non competitive redemption game. The Player shoots balls from an air cannon at three lit holes, trying to avoid the rotating propeller that passes by each hole. After the ball passes through an illuminated hole, the light turns off. After all three lit holes have a ball passed through, the "score Multiplier " increments and the holes light up again. This continues until time expires. Tickets are awarded based upon the score obtained in the time frame allowed.

CONDITIONS

- 1.) The maximum price to play shall not exceed values set forth in N.J.A.C. 13:3-3.4.
- 2.) Payout must occur immediately upon a win.
- 3.) The game playfield shall be clean and free of debris.
- 4.) Game shall be installed and maintained according to manufacturer specifications.
