BOARD OF MARRIAGE AND FAMILY THERAPY EXAMINERS PUBLIC SESSION MINUTES JUNE 13, 2013

I. CALL TO ORDER

This scheduled meeting of the Board of Marriage and Family Therapy Examiners was called to Order by Chair Ben Beitin at 9:55 a.m., in the Hudson Room 124 Halsey Street, 6th floor, Newark, New Jersey.

IV. PUBLIC COMMENT

A. Rhoda Ondov, Legislative Chairperson, American Association of Marriage and Family Therapy (AAMFT-NJ)

- i. Ms. Ondov came before the Committee to inquire about the omission of Marriage and Family Therapy Examiners in Bills A-732 and S-2543 which makes it a crime of the third degree to practice without certain mental health licenses. Regulatory Analyst, Chuck Manning informed Ms. Ondov that he will look into the history of the Bills and report back at the July 11, 2013 meeting.
- ii. Ms. Ondov also inquired as to the status of N.J.A.C. 13:34-11.2(a)3i "Definition of "counselor" of "counseling" in the graduate degree title." *The Board informed Ms. Ondov that the Division of Law is reviewing the proposed change.*

VI. LEGISLATIVE/REGULATORY

- A. <u>Senate Bill S-2828</u> ~ This Bill permits courts to order involuntary outpatient treatment in any county; concerns patient compliance with taking medication. Upon motion by Ketrin Saud-Maxwell, seconded by Edward Reading, the Board voted to support the Bill with the suggestion that all plenary mental health licensees be included in the Bill. Voting in favor: all.
- **B.** <u>Senate Bill S-2727</u> ~ This Bill establishes the "Study Commission on E-Licensing" Upon motion by Edward Reading, seconded by Ketrin Saud-Maxwell, the Board voted to oppose the Bill because it is too vague. Voting in favor: all.
- C. <u>Assembly Bill A-4126</u> ~ This Bill seeks to establish the "Art Therapy Licensing Act." Upon motion by Edward Reading, seconded by Ketrin Saud-Maxwell, the Board voted to oppose the Bill because Art Therapy is a technique not broad enough for licensure. The Board suggests amending the Professional Counselor regulations to add "art therapy" as a speciality designation. Voting in favor: all.
- **D.** <u>Senate Bill S-2840</u> ~ This Bill provided confidentiality for emergency service peer counselors. *Upon motion by Edward Reading, seconded by Ketrin Saud-Maxwell, the Board voted to support the Bill with the suggestion that it provide for the protection of employment for those who seek mental health counseling. <i>Voting in favor: all.*
- E. N.J.A.C 13:34-9A and 31 The Board reviewed the proposed "State Board of Marriage and Family Therapy Examiners Professional Counselor Examiners Committee Custody/Parenting Time Evaluation and/or Termination of Parental Rights Evaluation." *Upon motion by Edward Reading, seconded by Jose Perez, the Board voted to adopt as proposed. Voting in favor: all.*
- F. <u>Debra L. Wentz, Ph.D, Chief Executive Officer, The New Jersey Association of Mental Health and Addiction Agencies, Inc. (NJAMHAA)</u>

The Board reviewed Ms. Wentz's May 3, 2013 letter regarding the Custody/Parenting Time Evaluation and Termination of Parental Evaluations (N.J.A.C 13:34-9A and 31). NJAMHAA is requesting that specific rules about disability determinations be incorporated into these regulations.

The Board determined that this is beyond the scope of the current rule proposal and it can be addressed by a future role proposal.

A. <u>Commission on Accreditation for Marriage and Family Therapy Education</u> (COAMFTE)

The Board reviewed the June 5, 2013 letter from COAMFTE informing the Board that the University of Saint Joseph's MA program has been granted a Renewal of Accreditation. *The Board accepted this as informational*.

VIII. AAMFT/NJAMFT MATTERS

Board Chair, Ben Beitin informed the Board that as of January 1, 2014 approximately one-forth of the examination questions will be related to crisis counseling.
