



**II. REGULATIONS** Title 13 Chapter 44K; General Provisions  
RE: N.J.A.C.13:44K Proposed Amendments  
Regulatory Analyst: Rachel Glasgow

The Council discussed N.J.A.C. 13:44K-2 and the educational requirements for obtaining a license as an occupational therapist. Since January 1, 2007, an applicant must possess a master's degree to sit for the NBCOT licensing examination. The Council discussed the requirements for an applicant for licensure who graduated from an approved program prior to that date with a bachelor's degree in occupational therapy and whether that applicant's education would be accepted. The Council determined that the regulations will include a provision that an applicant who, prior to January 1, 2007, held a bachelor's degree in occupational therapy and had met all other requirements for licensure, including passing the NBCOT examination, would meet requirements for licensure, even in the absence of a master's degree.

Ms. Glasgow discussed the pending sunset of the Council's regulations. At its July meeting, the Council voted to propose the regulations for readoption without change.

Ms. Glasgow asked the Council to consider alternative motions, including a motion to simultaneously propose with the "readopt without change" , a proposal to amend the regulations with changes discussed and approved at the July 2015 meeting and the December 2015 meeting.
