A. Senate Bills

S- 2497

This bill allows certain child support obligors in arrears to apply for certain licenses provided the applicant has made 12 consecutive timely child support payments.

The Council, upon motion made by Mariann E. Moran and seconded by Tiffany Charles, supports Bill S-2497 as this amendment will assist individuals to obtain employment and unable them to keep up with child support payments.

B. Assembly Bills

A- 3529

This bill requires a public body to record meetings and post proceedings on its Internet website.

The Council, upon the motion made by Tiffany Charles and seconded by Aida Mendez-Boud, voted that generally supports this bill, but notes that there may be difficulties in complying with some provisions due to the current staff limitations.
