\* "pending" incorporates all applications that are incomplete (ie. missing transcripts, NCE scores, supervision forms, etc), applicants that have been approved and have yet to pay their licensing fees, applicants that have been approved and are awaiting the results of their criminal history background check. Administrative staff is working with MIS to resolve these conflicts

## B. Licensed Rehabilitation Counselor (LRC) Licensure

Robert J. Pare, wrote to inquire as to the future of the designation. Mr. Pare is concerned that the designation may be discontinued, and requested clarity as to the title status of the designation. *The Committee determined to send Mr. Pare a letter explaining that currently the Licensed Rehabilitation Counselor (LRC) is a Practice Act. The Committee is waiting on the final vote.* 

# VII. <u>CORRESPONDENCE</u>

## A. <u>LPC supervision by an LCADC</u>

The Committee reviewed Chair of the Alcohol and Drug Committee, Edward Reading's March 7, 2013 memorandum suggesting criteria for a LPC to be supervised by a LCADC.

The Committee accepted this as informational, and will revisit in the course of revising their supervision regulation.

# B. <u>Robert Mantia, LAC from the Kintock Group</u>

The Committee reviewed Mr. Mantia's letter regarding frequency of supervision requirements for LAC's. Mr. Mantia inquired if the activities pursuant to N.J.A.C 13:34-13.1(d) should take place at certain regular intervals, or if the supervision frequency is at the discretion of the supervisor? *The Committee determined to write Mr. Mantia a letter informing him that* N.J.A.C 13:34-13.1(d) *does not specify frequency of supervision*.

## C. <u>Tennesee Board of Licensed Professional Counselors RE: License</u> <u>Reciprocity</u>

The Committee reviewed the letter dated March 11, 2013 submitted by Ms. Sherry Owen, Board Administrator of the Tennessee Licensing Board regarding license reciprocity. William Green, Chair presented to the Committee Tennessee Counseling Bill HB 1185/ S514 indicating his concerns regarding entering into a reciprocity agreement with a state that supports legislation of a discriminatory nature. *The Committee accepted this as informational.*

### D. <u>Clarification of the July 19, 2012 Public Minutes RE: Glenn Duncan's</u> Advanced Counselor Training (ACT) Program

Upon motion by W. Michael Shea, seconded by Diane Licht, the Committee clarified section **VIII. A. "Correspondence"** of the July 19, 2012 Public Minutes. In response to Mr. Glenn Duncan's June 7, 2012 letter regarding supervisor qualifications. The Committee asked Mr. Duncan to provide the course content of his 30 hour workshop for informational purposes only. The Committee clarified that it is Not authorized to provide approval of courses, as required in preparation for obtaining the Approved Clinical Supervisor (ACS) certificate issued by the Center for Credentialing and Education (CCE) of the National Board of Certified Courselors (NBCC). The Committee reiterated the requirements for supervisor qualifications are laid out in: <u>N.J.A.C</u> 13:34-13.1:

"a) A qualified supervisor, as defined in N.J.A.C. 13:34-10.2, shall meet the following requirements prior to supervising the provision of professional counseling services: 1) The individual shall have obtained 3,000 hours of work experience subsequent to holding a clinical license to provide mental health counseling services. The 3,000 hours shall have been obtained over a minimum of two years, but no more than six years; and

2) On or after October 5, 2011, the individual shall hold an approved clinical supervisor credential from the Center for Credentialing and Education of the National Board for Certified Counselors (NBCC) or an equivalent clinical supervisor credential recognized by the individual's respective professional healthcare licensing board, if applicable, or shall have completed a minimum of three graduate credits in clinical supervision from a regionally accredited institution of higher education."

Voting in favor of motion: all.

## A. <u>ACA Code of Ethics</u>

The Committee reviewed the email from David Kaplan requesting the Committee's feedback regarding the first draft of the 2014 ACA Code of Ethics. *The Committee tabled this matter for further discussion.* 

## IX. COUNSELOR EDUCATION PROGRAMS

## A. <u>Cairn University (formally Philadelphia Biblical)</u>

The Committee reviewed the March 25, 2013 letter from Dr. Jeffrey Black of Cairn University and supporting documentation regarding course content. *The Committee determined to accept the degree title change from Masters of Science in Christian Counseling to Masters of Science in Counseling.* 

## B. <u>Review of College Courses</u>

Executive Director, Milagros Collazo reported many of the approved curriculum at area colleges/universities, will be requiring review for continued approval. Committee staff is requesting the Committee's guidance on the review process including: start date, materials to request, and the process for review/approval. *The Committee determined to have staff send letters to all colleges/universities that will be expiring to report substantive changes to their programs and to forward updated course curriculum to the Committee for review.*
