- C. **Public Law 2010, Chapter 17**
The Committee reviewed and accepted as informational a copy of the newly enacted law which requires the disposition of consumer complaints within 120 days.
- D. **A-2672**
This bill would require health care professionals to notify patients of end of health benefits coverage during the course of treatment in certain circumstances.
