CORRESPONDENCE

Robin Koslowitz, Ph.D., TP #093-033

Dr. Koslowitz wrote requesting an extension of her three-year supervised temporary permit beyond the September 21, 2012 expiration date.

Acting Deputy Director Puteska along with Acting Director Eric Kanefsky expressed their strong concern for this type of behavior and recommended therapists engaging in this behavior warrant disciplinary action.

Walden University

Supplemental information was submitted by Dr. Powell for the Board's review concerning Walden's Academic Year in Residence (AYR) session for students enrolled in the program prior to the Fall Quarter of 2011, which is prior to the adoption of the new regulations concerning educational requirements.

Upon motion made by Dr. Korwin and seconded by Dr. Wolf-Mehlman, the Board voted to do a final review of this program upon receipt of all the requested information from Walden University. Voting in favor of the motion: all.

News Release from the Association of State and Provincial Psychology Boards (ASPPB)

ASPPB reported that it has been selected to receive grants concerning licensure

portability from the Health Resources and Services Administration (HRSA), a division of the U.S. Department of Health and Human Services in the amount of \$349,785 each for three (3) years.
