NEW JERSEY STATE BOARD OF SOCIAL WORK EXAMINERS PUBLIC SESSION MINUTES WEDNESDAY, JUNE 8, 2016

I. CALL TO ORDER

The meeting was called to order at 9:45 a.m. in the Hudson Conference Room, 6th floor, 124 Halsey Street, Newark, New Jersey by Board Chair Dawn Hall Appar.

Announcement of Quorum

Board Chair Dawn Hall Apgar announced there was no quorum and that the Board would work as a Committee at 9:40 a.m.

In accordance with Chapter 231 of P.L. 1975, more commonly referred to as the Sunshine Law, adequate notice of this meeting was provided by mailing to the Office of the Secretary of State, The Star Ledger, The Trenton Times, The Record and The Courier Post.

III. REVIEW OF MINUTES

The Committee reviewed the May 11, 2016 public session minutes. Upon motion made by Dr. Hall Apgar, and seconded by Ms. Braun Scalera, the Committee voted to recommend approval of the May 11, 2016 minutes as presented. Voting in favor: all.

IV. EXECUTIVE DIRECTOR'S REPORT

Dr. Walker discussed with the Committee that Elite Continuing Education's courses are not approved by the ASWB NJ and that they have taken down the courses that were previously shown as approved. Once they have been accepted by the ASWB NJ as approved courses, they will be offered by Elite at a 10% discount. Dr. Walker will clarify with Elite what will happen to licensees who have already signed up for the courses, and if payment for unapproved courses will be refunded. If the courses be approved by the ASWB NJ asked the Board to retroactively accept the courses by licensees who signed up for the courses prior to approval, and the Board agreed. There will also be a notification put on the www.njconsumeraffiars.gov/sw website to remind licensees that individual courses need to be approved by NJ for NJ continuing education credit.

The Committee responded that clinical experience over five (5) years will not be accepted unless the application has current clinical experience, and may need to be working under supervision to show clinical competency. The exam is not enough to show clinical competency.
