# **New Jersey State Board of Veterinary Medical Examiners**

### July 25, 2001

### **Public Session Minutes**

### A. CALL TO ORDER

This scheduled meeting of the Board was called to order at 9:45 a.m. in the Somerset Conference Room, 6th floor, 124 Halsey Street, Newark, New Jersey.

### C. APPROVAL OF PUBLIC MINUTES

### **D. LEGISLATIVE/REGULATORY**

#### 1. Regulations

Regulatory Analyst Chuck Manning was present. The Board reviewed and responded to the one comment received as a result of the current batch of regulations being proposed. On a motion of Dr. Beeber, seconded by Dr. Self and unanimous vote, the Board voted to approve them for final publication in the New Jersey Register.

#### 1. Invoice re exam review and preparation

The Board discussed the invoice received from Dr. Michael Hennessy for review and preparation of item bank, sample test, analysis review, validation and other work related to administration of the October 2000 and April 2001 practical examinations. Copies of the invoice and related paperwork will be forwarded to Dr. Self and Dr. Meirs of the Examination Committee for their review and determination.

### F. CREDENTIALING

#### 1. Wallace Wass, DVM

On a motion of Dr. Meirs, seconded by Dr. Beeber and unanimous vote (with the exception of Dr. Self, who abstained), the Board approved Dr. Wass to sit for the jurisprudence exam.

#### 2. Tammy Anderson, DVM

The Board voted to send Dr. Anderson a letter requesting that she provide information on whether the three veterinarians who wrote endorsement letters for her are licensed in the State of Tennessee.

# **G. DISCIPLINARY ACTIONS**

#### 1. Dr. Mark Storch

Dr. Storch has paid the \$600 fine and \$240.76 costs in relation to a Consent Order concerning his participation in VetSmart vaccination clinics.

#### 2. Dr. Donald T. Force

Dr. Force has paid the \$250 fine for inadequate medical records in re File #01-007. This file is now closed.

#### 3. Dr. Aleda Cheng

Dr. Cheng has paid the \$600 fine and \$181 costs in relation to a Consent Order concerning her participation in Luv My Pet vaccination clinics.

#### 4. Dr. Edward Rose

Dr. Rose has paid the \$400 fine and \$135 costs in relation to a Consent Order concerning his participation in Luv My Pet vaccination clinics.

#### 5. Dr. Robert W. Kraybill
