Take notice that pursuant to N.J.S.A. 52:14B-5.1, the rules at N.J.A.C. 13:39 were scheduled to expire on November 3, 2024. The rules establish standards for the regulation and licensure of pharmacists, the registration of pharmacy technicians and interns, and the permitting of pharmacies.

Subchapter 1 sets forth rules concerning the purpose and scope of the chapter, definitions for terms used throughout the rules, fees, and

other general provisions. Subchapter 2 sets forth the requirements for initial licensure as a pharmacist and registration as a pharmacy intern. Subchapter 2A addresses requirements for reciprocal licensure. Subchapter 3 sets forth requirements related to pharmacist licenses. Subchapter 3A sets forth requirements for continuing education. Subchapter 4 sets forth pharmacy permit requirements. Subchapter 4A sets forth requirements for the remote processing of prescriptions. Subchapter 5 sets forth retail pharmacy requirements. Subchapter 6 sets [page=605] forth pharmacist in charge and pharmacy personnel requirements. Subchapter 7 sets forth requirements for drug dispensing and prescription records. Subchapter 8 is reserved. Subchapter 9 sets forth requirements for pharmaceutical services for health care facilities. Subchapter 10 sets forth requirements for automated medication systems. Subchapter 11 sets forth requirements for sterile compounding. Subchapter 11A sets forth requirements for nonsterile compounding. Subchapter 11B sets forth requirements for compounding antineoplastic agents and other hazardous substances. Subchapter 12 sets forth requirements for nuclear pharmacies. Subchapter 13 sets forth requirements for collaborative practice.

The Board of Pharmacy has reviewed the rules and has determined them to be necessary, reasonable, and proper for the purpose for which they were originally promulgated. Therefore, pursuant to N.J.S.A. 5:8-6, and in accordance with N.J.S.A. 52:14B-5.1.c(1), these rules are readopted and shall continue in effect for a seven-year period.
