**CONSENT ORDER**

This matter was opened to the New Jersey State Board of Nursing ("Board") upon receipt of Letisha L. Hogans' application for licensure as an Advanced Practice Nurse. The Applicant failed to disclose an arrest, answering "no" to the question which asked if she had ever been arrested and "no" to the question which asked if she had ever been found guilty of any offense. The applicant certified those answers to be true and accurate when she submitted the application.

Upon further Board investigation, the applicant acknowledged that on July 24, 1996, by the Millburn Township Police Department, she was arrested and charged with violating N.J.S.A. 2C:20-11 Shoplifting. On July 29, 1996, in Millburn Municipal Court, she was found guilty of N.J.S.A. 2C:20-11B(1) Shoplifting and assessed fines totaling five hundred ninety-eight dollars (\$598.00). She was arrested again on November 7, 1996, by the Woodbridge Police Department and charged with violating N.J.S.A. 2C:20-11B Shoplifting. On February 27, 1997, in Woodbridge Municipal Court she was found guilty of N.J.S.A. 2C:20-11B(1)

Shoplifting and assessed fines totaling five hundred thirty-three dollars (\$533.00). She was arrested again on March 20, 1997, by the Millburn Township Police Department and charged with violating N.J.S.A. 2C:20-11 Shoplifting. On June 2, 1997, in Millburn Municipal Court she was found guilty of violating N.J.S.A. 2C:20-11B(1) Shoplifting and assessed fines totaling eight hundred ninety-eight dollars (\$898.00). She was arrested again on April 3, 2006, by the Plainsboro Police Department and charged with violating N.J.S.A. 2C:12-1A(1) Simple Assault, N.J.S.A. 2C:12-12-1B Aggravated Assault and N.J.S.A. 2C:24-4 Endanger Welfare of Children. On August 23, 2006, in Plainsboro Municipal Court she was found not guilty and acquitted of N.J.S.A. 2C:12-1A Simple Assault and N.J.S.A. 2C:33-2A(1) Improper Behavior. She was arrested again on February 17, 2008, by the Bridgewater Township Police Department and charged with violating N.J.S.A. 2C:20-11B(2) Shoplifting. On April 2, 2008, in Bridgewater Municipal Court the charges were dismissed. She was arrested again on December 24, 2008, by the Freehold Township Police Department and charged with violating N.J.S.A. 2C:20-11 Shoplifting. On June 9, 2009, in Freehold Township Municipal Court the two (2) charges of 2C:20-11C(4) Shoplifting, one (1) count of N.J.S.A. 2C:20-7A Receiving Stolen Property and N.J.S.A. 2C:20-11F Possess Anti-Shoplifting Device were dismissed.

The Board finds that the applicant engaged in misrepresentation on the application which constitutes a violation of N.J.S.A. 45:1-21(b).

The Board having reviewed this matter, and having considered the nature and timing of the above conduct, and the parties desiring to resolve this matter, and the Board having determined that the within Order is sufficiently protective of the public, the Applicant waiving any right to a hearing, in lieu of further proceedings, and for other good cause shown;

IT IS on this 4<sup>th</sup> day of December, 2019

**HEREBY ORDERED AND AGREED that:**

1. Letisha L Hogans' application for licensure as an Advanced Practice Nurse shall be granted upon Board review and approval of a completed application and compliance with paragraph two below.

2. A civil penalty in the amount of five hundred dollars (\$500) is hereby imposed upon the applicant for misrepresentation on the application. Payment shall be made by certified check, bank cashier check, or money order payable to "State of New Jersey," or by wire transfer, direct deposit, or credit card payment submitted contemporaneously with this signed Order. Any other form of payment will be rejected and will be returned to the party making the payment.

3. The applicant shall obey all the laws of the State of New Jersey, the United States and their political subdivisions, as well as all regulations, rules or laws pertaining to the practice of nursing in any State or jurisdiction in which they practice nursing.
