ORDER OF REINSTATEMENT
TO PRACTICE AS A PHARMACIST :
IN THE STATE OF NEW JERSEY :

This matter was opened to the New Jersey State Board of Pharmacy (the Board) upon receipt of John Agyemang's (Respondent) petition for reinstatement of his license to practice as a pharmacist in the State of New Jersey.

On May 15, 2015, Respondent was convicted of second-degree possession of a weapon for an unlawful purpose, pursuant to N.J.S.A. 2C:39-4(a)(1) and third-degree criminal restraint, pursuant to N.J.S.A. 2C:13-2(a)(2). On September 19, 2016, Respondent entered into a Consent Order with the Board of Pharmacy whereby he agreed to a suspension of his license to practice

pharmacy in New Jersey for a minimum of three (3) years. At that time, the Board found that disciplinary action was warranted in that Respondent had engaged in professional misconduct and engaged in acts constituting crimes which relate adversely to the practice of pharmacy in violation of N.J.S.A. 45:1-21(e) and (f), providing a basis for discipline of his license to practice pharmacy in New Jersey.

On February 25, 2020, Respondent appeared before the Board and testified in support of his application for reinstatement of his pharmacy license. During his appearance, Respondent answered the Board's questions regarding the circumstances of his conviction, his compliance with the Board's Consent Order and what he has done since the Board took disciplinary action against him more than three years ago. Prior to his appearance, Respondent had provided documentation, as required in the 2016 Consent Order, as to his successful completion of the terms of his criminal sentencing and the requirements under the Board's Order. Respondent provided documentation of his successful completion of the PROBE ethics course and documentation that he had complied with the required psychological evaluation. Respondent also testified that he kept current with the Board's continuing education requirements. The Board was satisfied that Respondent

had satisfied the terms of the Consent Order and had demonstrated evidence of rehabilitation such that it was appropriate to reinstate his license.

The parties agreeing to resolve this matter, Respondent waiving any right to a hearing, the Board finding that the within Order is sufficiently protective of the public health, safety and welfare, in lieu of further proceedings, and for other good cause shown;

ACCORDINGLY IT IS on this 24 day of March, 2020

HEREBY ORDERED AND AGREED that:

1. Respondent's license shall be reinstated following provision of proof of successful completion of all application requirements including a criminal history background check with results that are satisfactory to the Board and payment of all reinstatement fees.

2. Respondent shall obey all the laws of the State of New Jersey, the United States and their political subdivisions as well as all regulations, rules or laws pertaining to the practice of pharmacy in the State or jurisdiction in which he practices pharmacy.

3. Respondent is required to report to the Board any arrest, indictment, or conviction for any crime or disorderly persons offense within ten (10) days. Any arrest, indictment, or

conviction for any crime or disorderly persons offense within 2 years from the date of this order shall constitute a violation of this Order.

4. Respondent acknowledges that he has been specifically advised of his right to have this Order reviewed by an attorney of his choosing. He enters this Order knowingly and voluntarily and acknowledges that there have been no other representations or agreements not stated in writing herein.

5. The Board reserves the right to bring further disciplinary action.
