#### Notice of Readoption

##### Charitable Fund Raising

Authority: N.J.S.A. 45:17A-18 et seq., specifically 45:17A-21b.

**Take notice** that pursuant to N.J.S.A. 52:14B-5.1, the rules at N.J.A.C. 13:48 were scheduled to expire on January 25, 2018. The rules implement the Charitable Registration and Investigation Act, P.L. 1994, c. 16 (N.J.S.A. 45:17A-18 et seq.), as amended by P.L. 2005, c. 283.

Subchapter 1 contains the general provisions relating to charitable fund raising. Subchapter 2 concerns the registration and other fees relating to charitable fund raising. Subchapter 3 contains general requirements for charitable fund raising in New Jersey. Subchapter 4 addresses the requirements for registration by charitable organizations on the short form registration statement. Subchapter 5 addresses the long form registration statement. Subchapter 6 addresses registration of local units by parent organizations. Subchapter 7 addresses registration of fund raising counsel and independent paid fund raisers. Subchapter 8

concerns registration of solicitors. Subchapter 9 addresses contracts and charitable sales promotions reports. Subchapter 10 sets forth recordkeeping requirements. Subchapter 11 contains the rules on fund raising practices. Subchapter 12 sets forth a charitable organization's responsibility for fund raising activities. Subchapter 13 addresses acts or omissions that are considered violations of the Act and rules. Subchapter 14 sets forth the penalties for a violation of the Act or the rules. Subchapter 15 imposes certain requirements on organizations engaged in charitable activity that limit membership to former law enforcement officers.

The New Jersey ***Division of Consumer Affairs*** has reviewed the rules and has determined them to be necessary, reasonable, and proper for the purpose for which they were originally promulgated, as required by Executive Order No. 66 (1978). Therefore, pursuant to N.J.S.A. 45:17A-18 et seq., specifically 45:17A-21.b, and in accordance with N.J.S.A. 52:14B-5.1.c(1), these rules are readopted without amendments and shall continue in effect for a seven-year period.
