N.J.A.C. 13:45A-13 Example 1

Take notice that the Division of Consumer Affairs has discovered an error in the current text of N.J.A.C. 13:45A-13. The subchapter, adopted as new rules effective August 3, 1976 (see 8 N.J.R. 304(a) and 439(e)), included a subpoena form appended to the subchapter as Example 1. However, with the incorporation of the adopted repeal of N.J.A.C. 13:45A-13.9 (effective December 4, 1995 (see 27 N.J.R. 3566(a) and 4899(b)) into the Administrative Code through the 12/18/95 Code update, Example 1 was inadvertently deleted from the Code. Through this notice, published pursuant to N.J.A.C. 1:30-2.7, that deletion is corrected.

Full text of the corrected rule follows:
