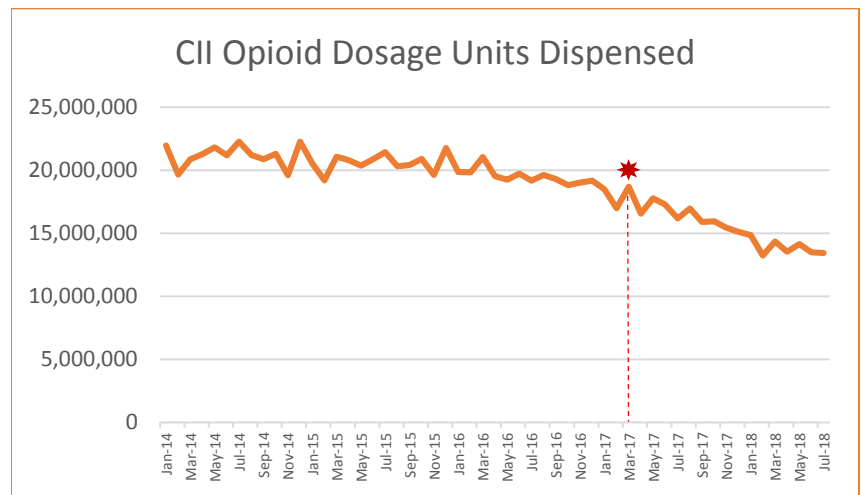
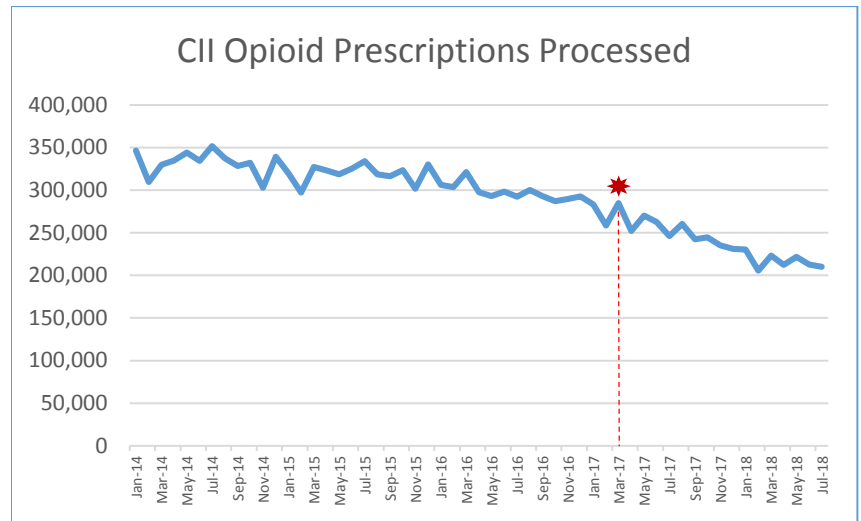

The number of Schedule II (CII) opioid prescriptions processed and dosage units dispensed in New Jersey decreased by **39%** between 2014 and 2018 YTD.

- \*Pre-mandatory 5-day rule: **18%** decrease in Opioid Prescriptions Processed
- \*Post-mandatory 5-day rule: **26%** decrease in Opioid Prescriptions Processed
- \*Pre-mandatory 5-day rule: **15%** decrease in Opioid Dosage Units Dispensed
- \*Post-mandatory 5-day rule: **28%** decrease in Opioid Dosage Units Dispensed
