V OLD BUSINESS

- A North Carolina - U.S. Supreme Court decision involving the powers of state boards
At their July 2015 meeting, the Board was informed of the recent U.S. Supreme Court decision involving the powers of state boards. After some discussion, the Board unanimously voted to send a memo to the Director of Division of Consumer Affairs with their concerns regarding the US Supreme Court's decision. At the May 12, 2016 meeting, Mr. Kirk informed the Board that there is no new information from the Division of Consumer Affairs. However, there is discussion toward formulating a policy within the Division concerning this matter. The Board unanimously voted to express the Board's disappointment that the Division has not provided some direction as to the protection of the board member's position acting on behalf of the state and this Board. Also that none of the state boards are participating in the discussion toward formulating a policy within the Division. On June 9, 2016, the Board expressed their concerns with Matthew Wetzel, Assistant Deputy Director, Division of Consumer Affairs. On July 14, 2016, Mr. Kirk informed the Board that there is no new directive from the Division with respect to this matter. Mr. Zaccone reiterated the Board's disappointment that the Division has not provided some direction as to the protection of the board member's position acting on behalf of the state and this Board. On March 9, 2017 Liza Ackerman, Regulatory Analyst, Division of Consumer Affairs, was present to update the Board members on A-4273 was amended to provide immunity and indemnification for board members. This bill passed the Assembly.

- 1 - Neil Werket* - On October 14, 2011, after some discussion, the Board determined to table this matter and request Mr. Werket to provide additional information. On July 12, 2012, the Board determined to table this matter. On February 14th, the Board tabled this matter. On March 14th, the Board reviewed a letter from Mr. Werket requesting an interview before the board pursuant to N.J.A.C. 13:27-8.4c. The Board determined to table this item until the next meeting pending receipt of additional information from the applicant. On July 11, 2013, the Board reviewed a copy of a letter dated June 24, 2013 from Mr. Werket as well as a copy of the letter from Educational Perspectives concerning the evaluation of his degree. Subsequent to reviewing the submitted information, the Board unanimously voted to advise Mr. Werket that based on the evaluation presented he does not meet the education requirement in New Jersey and he may wish to follow the recommendations made per the evaluation to him and re-submit his request for licensure. On July 10, 2014, the Board reviewed a copy of a June 14, 2014 e-mail from Neil Werket along with syllabuses for three classes noted in his letter for Board review and whether successful completion would fulfill the education requirement for licensure? Also attached for board information is the June 24, 2013 from Mr. Werket as well as a copy of the letter from Educational Perspectives concerning the evaluation of his degree. Subsequent to reviewing the submitted information, the Board unanimously voted to advise Mr. Werket to have the courses he wants to take at Rutgers evaluated and obtain an updated report that his education is substantial equivalent.
