On May 9, 2013, the Board unanimously voted to issue the settlement letter with the addition of Mr. Pimpao to take two 3-credit college ethics course. On June 12th, the Board reviewed a copy of the signed settlement letter from Mr. Pimpao; a copy of the Board's May 23rd letter regarding the ethics course he needs to complete; and copies of certificates of completion from Mr. Pimpao. The Board tabled this matter until the next meeting. On July 10th, the Board reviewed a copy of the signed settlement letter from Mr. Pimpao; a copy of the Board's May 23rd letter regarding the ethics course he needs to complete; and copies of certificates of completion from Mr. Pimpao. After some discussion, the Board unanimously voted to advise Mr. Pimpao that the courses he took were denied and did not satisfy the requirement in the settlement letter. Advise him that he has 30 days to provide proof that he has signed up for two (2) three-credit college courses on ethics. On September 11, 2014, the Board unanimously voted to send a letter to Mr. Pimpao advising that the professional practice course was accepted by the Board. However, the Construction Management course was not approved and he needs to submit an additional course for board approval to comply with the settlement letter. On February 12, 2015, the Board reviewed information from Mr. Pimpao pertaining to proof and grade for the professional practice course and submits business ethics courses as well as curriculum of three architectural schools for board review and approval. Mr. Zaccone will review the curriculum report to the Board at the April meeting.

Copy of a letter from Steven Considine, concerning the Site Plan Rule specifically, <u>N.J.A.C.</u> 13:27-7.3c and 7.3d.

ACTION: Mr. Zaccone motioned to inform Mr. Considine that the site plan rule provided as follows: (c) Drainage facilities for site plans of 10 acres or more; or involving storm water detention facilities; or traversed by a water course: By an engineer only. Each part is separate and distinct and can be designed only by an engineer. Thus, if the site is more than 10 acres, then he could not design (amount of acres does not matter). If the site is traversed by a water course, then he could not design (amount of acres does not matter). However there is not enough information to determine if the dry well is applicable to this rule. Request Mr. Considine provide more information concerning this project. Mr. Margiotta seconded the motion. It passed unanimously.

2 Copy of a letter from J Michael Perry, PE, PP, RA, concerning the Site Plan Rule specifically, N.J.A.C. 13:40-7.3(i).

ACTION: Mr. Zaccone motioned to inform Mr. Perry that as a licensed architect and as a licensed professional engineer he is permitted to prepare landscape plans in accordance with <u>N.J.A.C.</u> 13:40-7.3(I). Mr. Joshi seconded the motion. It passed unanimously.

Copy of an e-mail from Vincent Zadjeika of Greentech Builders concerning problems obtaining a certificate of occupancy on a home he completed under N.J.S.A. 45:3-10.

ACTION: Mr. Zaccone motioned to inform Mr. Zadjeika that it appears he does not meet the requirements for single family exemption under <u>N.J.S.A.</u> 45:3-10 and he needs an architect to review and approve the plans. The certificate of occupancy issue is outside the Board's jurisdiction. Mr. Margiotta seconded the motion. It passed unanimously.
