JAMES H. GANDY, UNLICENSED

ASSEMBLY BILL NO. 3317

12. Board to review Assembly Bill No. 3317 (received Richard T. Aicher, Jr., Board Member) which amends "The Electrical Contractors Licensing Act of 1962," to eliminate the exemption provided by that act from its electrical contracting permit requirements for any electrical installation, repair or maintenance work performed by regular employees of the State or of a municipality, county, or school district on the premises or property owned or occupied by the State, a municipality, county or school district.
