

**777 BUSINESS MEETING OF  
THE BOARD OF EXAMINERS OF ELECTRICAL CONTRACTORS  
(PUBLIC SESSION) SEPTEMBER 1, 2004**

The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the Special Meeting held July 21, 2004.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve the Minutes of the 776 Meeting held August 4, 2004, with the following correction:

Page 4, Paragraph 5

Motion made by Mr. Robert A. McCullough and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the course entitled "Internet" is not approved as the Board does not feel that the course submitted meets the criteria of Continuing Education.

Motion made by Mrs. Gail Best and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (13) Initial Licenses effective September 1, 2004 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (12) Initial Business Permits effective September 1, 2004 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (6) Initial Business Permits Previously Expired effective September 1, 2004 to March 31, 2006.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Robert A. McCullough, and unanimously passed, to approve (10) Changes in Business Permits effective September 1, 2004 to March 31, 2006.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778, as the twentieth installment of a civil penalty in the amount of \$2,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$2,000.00.

The Board accepted the payment.

Postal Money Order in the amount of \$300.00 received from John J. Helmstetter, License #7192, as the third installment of a civil penalty in the amount of \$7,500.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started June 7, 2004 and the balance due is \$6,600.00.

Motion made by Mr. James H. Flaherty and seconded by Mrs. Pushpavati Amin, and unanimously passed, that a letter be sent to Mr. D'Arcio advising him that he must take and pass the written examination in order to regain his license.

The sub-committee reviewed the application for Continuing Education Course/Seminar approval received from Thomas Pernal requesting approval of new courses.

The sub-committee reviewed the application for Continuing Education Course/Seminar approval received from Lawrence Cross requesting approval of new courses.

The Sub-committee reviewed the application for Continuing Education Course/Seminar approval received from Rhett Thomas, Lutron Electronics, requesting approval of new courses.

Motion made by Mr. Robert A. McCullough and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that a letter be sent to Mr. Thomas advising him that the courses as submitted are not approved as they do not meet the criteria of Continuing Education. It is the opinion of the Board that the courses submitted are product specific to Lutron Electronics.

The Board reviewed the Department of Community Affairs draft agenda for the Code Advisory Board meeting held August 13, 2004 and the approved Minutes of the Code Advisory Board meeting held on April 23, 2004.

Mr. McCullough stated that the Code Advisory Board discussed the proposed changes to the Rehabilitation Sub Code. Mr. McCullough also stated that New Jersey has created a prescriptive set of requirements to follow when working in existing buildings.

Signed cease and desist agreements were received from Mariusz Wrobel, Langhorne, Pennsylvania, and Scott Flammer, West Milford, New Jersey.

The Board accepted the signed cease and desist agreements.

The Board reviewed applications for the written examination to be administered by Experior Assessments, LLC. Twenty-three (23) applications were approved.

Motion made by Mrs. Gail Best and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, that the Board go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
