Board meeting of October 2, 2013, was called to order at 9:00 A.M. The following members were present:

Also in attendance were Eric DeGesero, New Jersey Independent Electrical Contractors, Robert Spellmon and Joseph McMullen, Members of the Electrical Contractors Association of New Jersey.

The Board saluted the Flag.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (23) Initial Licenses effective October 2, 2013 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (20) Initial Business Permits effective October 2, 2013 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (6) Initial Business Permits Previously Expired effective October 2, 2013 to March 31, 2015.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, to approve (5) Changes in Business Permits effective October 2, 2013 to March 31, 2015.

Check in the amount of \$25.00 received from Frank D'Arpa, License #8778 (Inactive), as the sixty-sixth installment of a civil penalty in the amount of \$2,500.00 for violation of $\underline{\text{N.J.S.A}}$. 45:5A-9 and $\underline{\text{N.J.S.A}}$. 56:8-1 et seq. Payments started September 25, 2002 and the balance due is \$850.00.

The Board accepted the penalty.

Check in the amount of \$100.00 received from Christian Rupp, License #8140, t/a C R Electrical Contracting, as the tenth installment of a civil penalty in the amount of \$2,700.00 for violation of N.J.S.A. 45:5A-9 and N.J.S.A. 56:8-1 et seq. Payments started November 14, 2012 and the balance due is \$1,700.00.

The Board accepted the penalty.

Postal Money Order in the amount of \$300.00 received from Robert T. Brown, License #10584, t/a R T Brown Electrical Contracting, Inc., as the twelfth and final installment of a civil penalty in the amount of \$2,500.00 for violation of $\underline{\text{N.J.S.A}}$. 45:5A-13.1 et seq., $\underline{\text{N.J.S.A}}$. 45:1-21(h), $\underline{\text{N.J.A.C}}$. 13:31-1.7(b), and $\underline{\text{N.J.A.C}}$. 13:31-1.7 (c). Payments started November 14, 2012.

The Board accepted the penalty.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Joanna Osoliniec, Institute for Technical Advancement, LLC, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Joseph F. Cantalupo, and unanimously passed, to approve seven (7) new courses and instructors and the nine hours of code changes and the one hour of Laws, Rules and Regulations.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Victor V. Timpanaro, d/b/a Technical Seminars, LLC, requesting approval of new courses.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. Timpanaro's request be held in abeyance. Mr. Timpanaro will be advised that the course hours do not accurately add up. Mr. Timpanaro will also be requested to submit a copy of Mr. Barone's resume and a more detailed outline for the courses for which he is requesting expanded hours.

The Board reviewed an application for Continuing Education Course/Seminar Approval received from Thomas McNulty, Penn-Del-Jersey Chapter, NECA, requesting approval of new on-line courses.

Mr. McNutly's request was held in abeyance pending instructor names and course hours.

E-mail received from Mr. McNutly stating that the on-line courses are on demand with no instructors or time limits.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that Mr. McNutly's request is denied as webinar courses must be instructor led.

Signed cease and desist agreement received from Lewis P. Lockburner, Sussex, New Jersey and James D. Graul, The House Husband.

The Board accepted the signed cease and desist agreement.

E-mail dated August 6, 2013, received from Terry Fober stating that he is an out of state general electrical contractor and would like to know whether or not his company would be considered exempt pursuant to N.J.S.A. 45:5A-18(m). Mr. Fober states that his company sets and welds turbine isophase in power plants and builds high voltage electrical substations for independent power producers which are generally located within the boundaries of the power plant.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that a letter be sent to Mr. Fober advising him that it is the opinion of the Board that the work his company performs is not considered exempt pursuant to N.J.S.A. 45:5A-18 (e&f) as his company appears to be an independent developer and not regulated by the Board of Public Utilities.

Rachel Glasgow, Regulatory Analyst, appeared before the Board at 10:15 A.M. concerning the Board's proposed regulation N.J.A.C. 13:31-1.7 Continuing Education.

The Board advised Ms. Glasgow that it has concerns with the language which states licensees may earn up to four credits of continuing education by completing correspondence and self-study courses. The Board advised Ms. Glasgow that it has always been their opinion that licensees be allowed to earn four credits in interactive, instructor led, live webinars.

Ms. Glasgow stated that the Board can chose not to adopt the proposed language.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Mitchell R. Malec, and unanimously passed, that the Board withdraw the previously approved proposal for <u>N.J.A.C</u>. 13:31-1.7 Continuing Education as attendance compliance cannot be demonstrated.

Ms. Glasgow discussed the Board's request to draft language that certain organizations/associations be given blanket approval to teach continuing education courses to licensees as long as the organization/association meets the Board's general guidelines.

Motion made by Mr. Mitchell R. Malec and seconded by Mr. Constantinos Papademas, and unanimously passed, that the Board not pursue drafting such a regulation.

The Board reviewed applications for the written examination to be administered by Thomson Prometric. Twenty-two (22) applications were approved.

Motion made by Mr. Joseph F. Cantalupo and seconded by Mr. Constantinos Papademas, and unanimously passed, to go into Executive Closed Session to consider and to review consumer complaints, investigative reports and other information received pursuant to the Board's investigative authority in order to determine whether violations of the law, including Board regulations have occurred. The results of the deliberations will be made known when and if the Board determines to initiate disciplinary action or other law enforcement action.
