## 1. <u>N.J.A.C.</u> 13:37-14: Homemaker- Home Health Regulations

The Committee reviewed and discussed amendments N.J.A.C. 13:37-14.3 that would require a registered professional nurse to review a plan of care with a certified homemaker-home health aide who has been newly assigned to a patient. The registered professional nurse must meet with the certified homemaker-home health aide if the nurse determines that the aide is prepared to perform the tasks in the plan of care.

## Responsibilities of licensure

A licensee shall be held to the level of practice associated with his or her licensure, either as a registered professional nurse or licensed practical nurse, regardless of his or her employment status. For example, when a registered nurse is employed as a licensed practical nurse, he or she will be held to the standards of a registered professional nurse.

The committee reviewed and discussed amendment N.J.A.C. 13:37-5.6 and has decided to meet with some of the CNOs (Chief Nursing Officer) to further discuss this issue and maybe develop some interpretive guidance that could disseminate to all of the healthcare organizations.

# 2. N.J.A.C. 13:37-14: Homemaker- Home Health Regulations

The Committee reviewed and discussed amendments N.J.A.C. 13:37-14 that would: set forth when a registered professional nurse is required to meet with a certified homemaker-home health aide; require program coordinators to attend a Board orientation: require applicants for certification as homemaker-home health aides to

complete a Board competency examination; require that homemaker-home health aide education programs include a review of Board statutes and regulations; prohibit certified homemaker-home health aides from engaging in sexual misconduct; and impose prohibitions on certified homemaker-home health aides obtaining power of attorney over patients.

Chuck Manning will revise draft amendments to N.J.A.C. 13:37-14 and bring these revisions to the next Committee meeting.

## 3. N.J.A.C. 13:37-5.6: Responsibilities of licensure

The committee reviewed and discussed amendments to N.J.A.C. 13:37-5.6 with Teresa DiElmo from SBHCS, Diann Johnston from SBHCS and Ruben Fernandez from PMC. Chuck Manning will work on amendments to N.J.A.C. 13:37-5.6 and bring these to the next Committee meeting.

# **SITE VISIT:**

a. Pineland School of Practical Nursing & Allied Health, Inc.

A site visited was conducted on January 12, 2010 to determine if the program is eligible for full accreditation.

Representatives from Lincoln Technical Institute appeared before the Board to provide additional information about improvement plans for the program.

After discussion the Board, upon a motion made by Saundra Austin-Benn and duly seconded by Karen Rodriguez, voted to deny the request of Lincoln Tech until all three sites have pass rates above 75%. The motion carried.
