#### **CHHA Criminal History Background Check Considerations**

Pursuant to P.L. 2021 c. 81 (N.J.S.A. 45:1-21.5), which went into effect August 9, 2021, the Board must now determine whether an applicant's criminal history has a direct or substantial relationship to the activity regulated by the Board or is of a nature such that issuing a certification to practice would be inconsistent with the public's health, safety. In considering the applicant, the Board must also consider the following:

- (1) The nature and seriousness of the crime or offense and the passage of time since its commission:
- (2) The relationship of the crime or offense to the purposes of regulating the profession or occupation regulated by the Board;
- (3) Any evidence of rehabilitation ... that may be made available to the Board; and
- (4) The relationship of the crime or offense to the ability, capacity, and fitness required to perform the duties and discharge the responsibilities of the occupation regulated.
