#### NEW JERSEY STATE BOARD OF OPTOMETRISTS REGULAR SESSION MINUTES NOVEMBER 19, 2003

A regular meeting of the New Jersey State Board of Optometrists was held at 124 Halsey Street, Newark on the 6th floor on Wednesday, November 19, 2003. Leonard Steiner, O.D., President of the Board, announced that pursuant to the Open Public Meetings Act, Chapter 321, P.L., notice of this meeting was prepared in the office of the Board and mailed out to the Secretary of State, the Attorney General, the Star Ledger, the Record, the Press of Atlantic City, the Asbury Park Press, and the Trenton Times. ## **III. New Business**

# A. Letter from Harvey Richman, O.D. and Maria Santullo Richman, O.D. RE: CPT Codes

Drs. Richman advised the Board that Health Net of NJ does not accept the 92004 and 92014 codes for comprehensive eye exams and have begun to "down-code" claims for routine vision care services from a comprehensive level to an intermediate level of service. A motion was made by Dr. Strulowitz and seconded by Dr. Collazo to advise Drs. Richman that the Board does not have jurisdiction over insurance companies. The Board will send Health Net of NJ the New Jersey State Board of Optometrists' statutes and regulations book and its CPT Code list for their review.

#### **B. Letter from Charles Fitzpatrick, O.D. RE: CPT Codes**

Dr. Fitzpatrick advised the Board that Aetna Health, Inc. will not accept certain CPT Codes submitted by optometrists. A motion was made by Dr. Strulowitz and seconded by Dr. Collazo to advise Dr. Fitzpatrick that the Board does not have jurisdiction over insurance companies. The Board will send Aetna Health, Inc. the New Jersey State Board of Optometrists's statutes and regulations book and its CPT Code list for their review.

# C. Letter from Bryan Markowitz, Executive Director of the New Jersey Society of Optometric Physicians RE: Continuing Education Courses

The New Jersey Society of Optometric Physicians asked the Board to consider approving courses that would be valid for a two or three calendar year period. The Board will notify course sponsors and advise them that the Board will implement an expiration date on all future Board approved courses. The expiration date that will be given to Board approved courses will be the last day of the biennium in which the course was approved, such as April 30, 2005. The course sponsors must keep the same title, Board approval number, and course lecturer. The course sponsor must notify the Board office of the date and location the course will be held again within 30 days of the course and provide the Board office with the attendance sheets. If the sponsor wishes to change the title or lecturer of the course, they will be required to reapply for Board approval.

# **D.** Notification from the American Optometric Association **RE**: Optometry Board Review of Leases for Space

The Board reviewed the notification from the American Optometric Association regarding optometry board review of leases for space and considered it informational.

### E. Letter from Arthur Muccilli, O.D. RE: 100 Hour Ocular Therapy Course

Dr. Muccilli advised the Board that he successfully completed the 100 hour course in ocular therapy given by the Pennsylvania College of Optometry in 1993 and was interested in taking the National Board of Examiners in Optometry's TMOD (treatment and management of ocular disease) exam in order to apply for TPA (therapeutic pharmaceutical agents) certification. Dr. Muccilli inquired whether the Board would accept his application for TPA certification if he passes the TMOD examination although he took and passed the 100 hour course 10 years ago. The Board will advise Dr. Muccilli that as long as he passed the 100 hour course after 1992 they will accept his application after he passes the TMOD examination.
