# NEW JERSEY STATE BOARD OF PSYCHOLOGICAL EXAMINERS MONDAY, MARCH 1, 2010 <u>PUBLIC SESSION MINUTES</u>

#### CORRESPONDENCE

#### Heather Watson, Ph.D., TP #063-672

Dr. Watson wrote requesting an extension of her three-year supervised temporary permit beyond its March 15, 2010 expiration date.

Dr. Watson stated that she is currently completing the required supervision hours to take the E.P.P.P. written examination. In reviewing Dr. Watson's extension request, the Board noted that there was no reason given by Dr. Watson as to why she was unable to complete the required hours before her permit had expired.

Upon motion made by Dr. Groveman and seconded by Ms. Winderman, the Board voted to extend Dr. Watson's temporary permit until its next meeting scheduled for April 5, 2010 and requested that she provide the Board with a reason for her permit extension request. Voting in favor of the motion: all.

Lisa Orsini, Ph.D., TP #083-874

Dr. Orsini wrote requesting additional time to submit her work sample to the Board office beyond her November 18, 2009 due date.

Dr. Orsini stated that she was not able to complete her work sample by the required date due to obstacles involved in obtaining a therapy patient in New Jersey.

Upon motion made Dr. Groveman and seconded by Ms. Winderman, the Board voted to give Dr. Orsini until July 1, 2010 to submit her work sample. Voting in favor of the motion: all.

Darlene Kane, Budget Office, Division of Consumer Affairs, submitted for Board's review the (1<sup>st</sup> half) FY2010 Budget Report. *The Board accepted the data as informational.* 

### Association of State and Provincial Psychology Boards

The Board of Psychological Examiners reviewed the Board Administrators/Registrars Committee Meeting draft minutes of October 28, 2009 in Coeur d'Alene, Idaho. *The Board accepted the minutes as informational*.

### Consumer Affairs; Office of the Director; Legislative Affairs; 4th Quarter

The Board received a report from the Division of Consumer Affairs, Office of the Director, Legislative Affairs, concerning legislative action for the 4<sup>th</sup> Quarter, October 1, 2009 to January 19, 2010. *The Board accepted the report as informational.* 

#### Patrice McGreevey, Psy.D.

The Board reviewed Dr. McGreevey's responses to specific questions with regard to the termination and transfer of her patients to Doreen Sperber-Weiss, Ph.D. when her temporary permit expired on December 4, 2009.

Upon motion made by Dr. Groveman and seconded by Dr. Roy, the Board voted to schedule Dr. McGreevey and Dr. Sperber-Weiss for a conference to address additional questions with regard to the termination and transfer of those patients. Voting in favor of the motion: all.

#### New Jersey Foundation for Aging

The Board reviewed the Press Release submitted with regard to a new law to protect vulnerable seniors. *The Board accepted the Press Release as informational.* 

#### Maureen S. O'Leary, MBA

Ms. O'Leary wrote inquiring whether a Ph.D. working in an exempt setting under the supervision of a New Jersey licensed psychologist can refer to a test as "psychological." Upon motion made by Dr. Roy and seconded by Dr. Groveman, the Board voted to inform Ms. O'Leary that individuals who are not licensed cannot use the term "psychology" or any of its duratives pursuant to <u>N.J.A.C.</u> 13:42-9.9. Voting in favor of motion: all.

### **REVIEW OF LEGISLATION**

Senate, No. 89–Requires licensed health care professionals and facilities to bill Medicare beneficiaries within six months of providing health care services.

The Board reviewed and discussed the bill and upon motion made by Dr. Groveman and seconded by Dr. Roy, the Board voted that for administrative reasons the six month limit to bill Medicare beneficiaries is too brief and suggest that a one-year limit would be more reasonable. Voting in favor of the motion: all.

### **OPEN DISCIPLINARY MATTERS**

### Kenneth Langlieb, Ph.D., #3073

Dr. Langlieb submitted for the Board's review a sexual boundary violations course entitled "Sexual Boundary Violations: Therapeutic, Supervisor, and Academic Contexts" for approval by the Board to satisfy the term of his Consent Order filed on October 30, 2009.

Upon motion made by Dr. Groveman and seconded by Dr. Roy, the Board voted to accept the sexual boundary violations course as satisfying the Consent Order requirement. Voting in favor of the motion: all.

Frank MacArthur, Psy.D., #3723

Dr. MacArthur submitted the names of Mark Cetta, Ph.D., Emanuel Shapiro, Ph.D. and Nina Thomas, Ph.D. for the Board's review along with their resumes, for approval to serve as his supervisor pursuant to the terms of the Consent Order filed on October 30, 2009.

Upon motion made by Dr. Roy and seconded by Dr. Brickfield, the Board was satisfied with all the licensed psychologists submitted and will allow Dr. MacArthur to make the final selection and inform the Board of his choice. Voting in favor of the motion: all.
