ATTENTION CLINICAL SUPERVISORS

N.J.A.C. 13:44 G-8.1(a)4

Beginning on **July 7, 2004**, clinical supervision shall be rendered by an LCSW with a minimum of three years of licensure as an LCSW and **who has completed at least 20 continuing education credits of post-graduate course work related to (clinical) supervision.**
